A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING \$20,700 TO FREE TO THRIVE FOR HUMAN TRAFFICKING AND TRAUMA-INFORMED SKILLS-BASED TRAINING FOR LAW ENFORCEMENT/GOVERNMENT AGENCIES AND SURVIVOR EMPOWERMENT PROGRAMS, PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-06, titled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by San Diego Resolution R-306903 (July 7, 2011); and

WHEREAS, among other things, Council Policy 100-06 establishes guidelines and uniform eligibility requirements for funding Community Projects, Programs and Services with non-profit community organizations and public agencies for community, social, environmental, cultural, or recreational needs which serve a lawful public purpose; and

WHEREAS, Free to Thrive has requested funding for human trafficking and trauma-informed skills-based training for law enforcement/government agencies and survivor empowerment programs; and

WHEREAS, the requested funding will be used (a) for staff time in developing, marketing, and conducting the trainings, printing training materials, and other items for in-person trainings, and (b) to increase Free to Thrive's capacity to address client needs in response to Covid through its three Survivor Empowerment programs: supporting programmatic and staff expenses as "resource navigators;" staffing its financial empowerment academy; and providing survivor stipends and emergency assistance and other related costs; and

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-06; and

WHEREAS, Council Districts 1, 2, 5, 6, 8, and 9 recommend a total allocation of \$20,700 to Free to Thrive for the purposes set forth in this resolution, attributed as follows: Council District 1 – \$4,000; Council District 2 – \$3,000; Council District 5 – \$3,000; Council District 6 – \$3,000; Council District 8 – \$2,700; and Council District 9 – \$5,000; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocation described in this resolution is made for a public purpose.

BE IT FURTHER RESOLVED, that the City Council waives Council Policy 100-06, section 3(g), which provides: "An organization may not apply to receive funding for an event or program which has already occurred, nor any capital improvement, goods, supplies, materials, or equipment which have already been purchased."

BE IT FURTHER RESOLVED, that the City Council waives Council Policy 100-06, section 8, which provides: "Community Projects, Programs and Services funding should be considered a one-time resource, and planned uses should be one-time in nature, to avoid service interruptions or employee impacts if funding is discontinued."

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized and directed to execute, for and on behalf of the City, a Community Projects, Programs, and Services FY 2022 City Council Allocations Agreement between the City of San Diego and Free to Thrive's (Agreement) in an amount not to exceed \$20,700 for the project described in this resolution, under terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No. RR- 313936.
