A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE SETTLEMENT AGREEMENT BETWEEN DARIN BARIONI, DECEASED, BY AND THROUGH HIS SUCCESSORS IN INTEREST, JENNY BARIONI AND GRACE BARIONI, GRACE BARIONI AND JENNY BARIONI; AND THE CITY OF SAN DIEGO.

WHEREAS, on October 2, 2015, Darin Barioni filed suit against the City of San Diego alleging personal injuries arising from a motorcycle accident that occurred on October 17, 2014, on Via Capri, La Jolla. The suit is entitled *Darin Barioni v. City of San Diego*: San Diego Superior Court Case No. 37-2015-00033388-CU-PO-CTL. On September 15, 2020, following Darin Barioni's death of June 17, 2020, Darin Barioni's daughters, Grace Barioni and Jenny Barioni, filed suit against the City of San Diego alleging personal injuries for the death of Darin Barioni, alleging that Darin Barioni's death was related to his motorcycle accident. The suit is entitled *Grace Barioni and Jenny Barioni v. City of San Diego*: San Diego Superior Court Case No. 37-2020-00032337-CU-NP-CTL. Both suits, *Darin Barioni v. City of San Diego*: San Diego Superior Court Case No. 37-2015-00033388-CU-PO-CTL, and *Grace Barioni and Jenny Barioni v. City of San Diego*: San Diego Superior Court Case No. 37-2020-00032337-CU-NP-CTL were consolidated [Consolidated Litigation]; and

WHEREAS, in Closed Session on January 25, 2022, the City Council, by the following votes: Yeas, Districts 1, 2, 3, 4, 5, 6, 7, 8, and 9; Nays, None, and Absent, None; approved the Settlement of the Consolidated Litigation for an amount consistent with the amounts set forth below;

NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Council:

- 1) Authorizes the Mayor or his designee to pay the sum of \$1,325,000.00 from Public Liability Fund No. 720045, in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorney fees, against City of San Diego, its agents and employees, arising from the Consolidated Litigation; and
- 2) Authorizes the Chief Financial Officer to expend an amount not to exceed \$1,325,000.00 from Public Liability Fund No. 720045, for the purpose of settling these claims. APPROVED: MARA W. ELLIOTT, City Attorney
