DATE OF FINAL PASSAGE MAR 22 2022

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING \$12,500 TO FEEDING SAN DIEGO FOR THE PURCHASED OF NEW PALLET JACKS, PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-06, titled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by San Diego Resolution R-306903 (July 7, 2011); and

WHEREAS, among other things, Council Policy 100-06 establishes guidelines and uniform eligibility requirements for funding Community Projects, Programs and Services with non-profit community organizations and public agencies for community, social, environmental, cultural, or recreational needs which serve a lawful public purpose; and

WHEREAS, Feeding San Diego has requested funding to help move, sort and organize pallets of food for distribution to food insecure individuals in the community; and

WHEREAS, the requested funding will be used to help cover the cost of purchasing three new pallet jacks, which are vital to food distribution efficiency, useful at Feeding San Diego's distribution center, and taken on trucks to help unload pallets of food at distribution sites; and

WHEREAS, Feeding San Diego's request for funding the pallet jacks will benefit the public by helping to feed children, families, seniors, college students, military families, veterans, people facing homelessness, and underserved and disadvantaged populations throughout San Diego County; and

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-06; and

WHEREAS, Council Districts 1, 6, 8, and 9 recommend a total allocation of \$12,500 to Feeding San Diego for the purposes set forth in this resolution, attributed as follows: Council District 1 – \$3,000; Council District 6 – \$2,000; Council District 8 – \$2,500; and Council District 9 – \$5,000; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocation described in this resolution is made for a public purpose.

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized and directed to execute, for and on behalf of the City, a Community Projects, Programs, and Services FY 2022 City Council Allocations Agreement between the City of San Diego and Feeding San Diego (Agreement) in an amount not to exceed \$12,500 for the project described in this resolution, under terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No. RR- 313956.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$3,000 from Council District 1: Community Projects, Programs and Services budget Fund No. 100000, G/L Account No. 512059, Cost Center No. 1101110001; \$2,000 from Council District 6: Community Projects, Programs and Services budget Fund No. 100000, G/L Account No. 512059, Cost Center No. 1106110006; \$2,500 from Council District 8: Community Projects, Programs and Services budget Fund No. 100000, G/L Account No. 512059, Cost Center No. 1108110008; and \$5,000 from Council District 9: Community Projects, Programs and Services budget Fund No. 100000, G/L Account No. 512059, Cost Center No. 1109110009, for a total of \$12,500, all to provide funds for the above-referenced Agreement, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying

that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
