A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING \$7,500 TO THE GRANDPARENTS CONNECTION, INC., FOR GRANDPARENTS CONNECTION – SOUTHEASTERN SAN DIEGO, PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-06, titled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by San Diego Resolution R-306903 (July 7, 2011); and

WHEREAS, among other things, Council Policy 100-06 establishes guidelines and uniform eligibility requirements for funding Community Projects, Programs and Services with non-profit community organizations and public agencies for community, social, environmental, cultural, or recreational needs which serve a lawful public purpose; and

WHEREAS, The Grandparents Connection, Inc., has requested funding for The Grandparents Connection – Southeastern San Diego; and

WHEREAS, the requested funding will be used to purchase refrigerators, coolers, barbeque grills, 20 laptops for computer classes, 10 canopies, volleyball system, generators, 15 food warmers, gazebo dressing room, popcorn machine, cotton candy machine, storage unit, photo booth, 2 wireless printers, and 1 desktop computer; and

WHEREAS, The Grandparents Connection's request for funding for The Grandparents

Connection – Southeastern San Diego will benefit the public by assisting on a weekly basis

grandparents who are raising children and relative caregivers; and

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-06; and

WHEREAS, Council Districts 4 and 5 recommend a total allocation of \$7,500 to The Grandparents Connection for the purposes set forth in this resolution, attributed as follows:

Council District 4 – \$5,000 and Council District 5 –\$2,500; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocation described in this resolution is made for a public purpose.

BE IT FURTHER RESOLVED, that the City Council waives Council Policy 100-06, section 3(g), which provides: "An organization may not apply to receive funding for an event or program which has already occurred, nor any capital improvement, goods, supplies, materials, or equipment which have already been purchased."

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized and directed to execute, for and on behalf of the City, a Community Projects, Programs, and Services FY 2022 City Council Allocations Agreement between the City of San Diego and The Grandparents Connection (Agreement) in an amount not to exceed \$7,500 for the project described in this resolution, under terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No. RR-313964.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$5,000 from Council District 4: Community Projects, Programs and Services budget Fund No. 100000, G/L Account No. 512059, Cost Center 1104110004 and \$2,500 from Council District 5: Community Projects, Programs and Services budget Fund No. 100000, G/L Account No. 512059, Cost Center 1105110005, for a total of \$7,500, all to provide

funds for the above-referenced Agreement, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

BE IT FURTHER RESOLVED, that this activity is exempt from CEQA pursuant to CEQA Guidelines Section 15301 (Existing Facilities) and 15323 (Normal Operation of Facilities for Public Gatherings), and that none of the exceptions to the exemptions found in CEQA Guidelines Section 15300.2 would apply.
