A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO AMENDING THE 2022 LEGISLATIVE
CALENDAR.

WHEREAS, each year, the Council of the City of San Diego (Council) adopts a schedule of meetings for the calendar year for the Council and its Standing Committees, commonly referred to as the legislative calendar; and

WHEREAS, the legislative calendar also includes the meetings of the Budget Review Committee, the Housing Authority, and the Public Facilities Financing Authority; and

WHEREAS, on October 12, 2021, the Council adopted the 2022 Legislative Calendar, on file in the Office of the City Clerk as Document No. RR-313743, and available on the City of San Diego's website; and

WHEREAS, on February 15, 2022, the Council adopted amendments to the 2022 Legislative Calendar, on file in the Office of the City Clerk as Document No. RR-313920, and available on the City of San Diego's website; and

WHEREAS, San Diego Municipal Code section 22.0101 allows the Council to adopt a resolution that changes, when necessary, the time and place of a regular meeting and sets forth the circumstances necessitating the change; and

WHEREAS, the Council President proposes to amend the 2022 Legislative Calendar, with changes to add new dates for the recently Council-approved Select Committee on San Diego Housing Commission Oversight and Reform; and

WHEREAS, the amendments proposed to the 2022 Legislative Calendar will:

4. Add a Select Committee on San Diego Housing Commission Oversight and Reform meeting on Monday, June 27, 2022, at 9:00 a.m.;
5. Add a Select Committee on San Diego Housing Commission Oversight and Reform meeting on Monday, July 25, 2022, at 9:00 a.m.;
6. Add a Select Committee on San Diego Housing Commission Oversight and Reform meeting on Monday, September 12, 2022, at 9:00 a.m.;
7. Add a Select Committee on San Diego Housing Commission Oversight and Reform meeting on Monday, October 17, 2022, at 9:00 a.m.;
8. Add a Select Committee on San Diego Housing Commission Oversight and Reform meeting on Monday, November 14, 2022, at 9:00 a.m.;
9. Add a Select Committee on San Diego Housing Commission Oversight and Reform meeting on Wednesday, December 7, 2022, at 2:00 p.m.; and

WHEREAS, these amendments to the Legislative Calendar are being made to schedule the meetings of the recently approved Select Committee on San Diego Housing Commission Oversight and Reform; and

WHEREAS, under San Diego Charter section 280(a)(1), this resolution is not subject to veto by the Mayor, because this matter is exclusively within the purview of the Council and does not affect the administrative service of the City under the control of the Mayor; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the 2022 Legislative Calendar is hereby amended as reflected in the amended 2022 Legislative Calendar, a copy of which is on file in the Office of the City Clerk as Document No. RR- 313975.
