A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING FUNDS TO BODHI TREE CONCERT, LA JOLLA ART & WINE FOUNDATION, SAN DIEGO COASTKEEPER, AND THEATRE AND ARTS FOUNDATION OF SAN DIEGO COUNTY DBA LA JOLLA PLAYHOUSE, PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-06, titled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by San Diego Resolution R-306903 (July 7, 2011); and

WHEREAS, among other things, Council Policy 100-06 establishes guidelines and uniform eligibility requirements for funding Community Projects, Programs and Services with non-profit community organizations and public agencies for community, social, environmental, cultural, or recreational needs which serve a lawful public purpose; and

WHEREAS, the City of San Diego received and evaluated four applications for Community Projects, Programs and Services funding for the following purposes:

WHEREAS, it is the determination of the City Council that the above-described programs fit within the parameters of Council Policy 100-06; and

WHEREAS, Council District 1 recommends an allocation of \$2,500 to Bodhi Tree Concert for paying local artists to perform as set forth in this resolution; and

WHEREAS, Council District 1 recommends an allocation of \$5,000 to La Jolla Art and Wine Foundation for covering rental fees including tents, tables, chairs, and staging equipment as set forth in this resolution; and

WHEREAS, Council District 1 recommends an allocation of \$2,500 to San Diego Coastkeeper for clean-up event equipment, printing materials, and directly support staff as set forth in this resolution; and

WHEREAS, Council District 1 recommends an allocation of \$3,000 to Theatre and Arts Foundation of San Diego County dba La Jolla Playhouse for covering the fees of five local artists and art groups who will be performing at the Pop-Up WOW event as set forth in this resolution; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocations described in this resolution are made for a public purpose.

BE IT FURTHER RESOLVED, that, for the La Jolla Art & Wine Foundation and Theatre and Arts Foundation of San Diego County dba La Jolla Playhouse, the City Council waives Council Policy 100-06, section 3(g), which provides: "An organization may not apply to receive funding for an event or program which has already occurred, nor any goods, supplies, or materials which have already been purchased."

BE IT FURTHER RESOLVED, that, for the San Diego Coastkeeper and Theatre and Arts Foundation of San Diego County dba La Jolla Playhouse, the City Council waives Council Policy 100-06, section 8, which provides: "Community Projects, Programs and Services funding should be considered a one-time resource, and planned uses should be one-time in nature, to avoid service interruptions or employee impacts if funding is discontinued."

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized and directed to execute, for and on behalf of the City, a Community Projects, Programs, and Services FY 2022 City Council Allocations Agreement between the City of San Diego and (1) Bodhi Tree Concert in an amount not to exceed \$2,500, (2) La Jolla Art & Wine Foundation in an amount not to exceed \$5,000, (3) San Diego Coastkeeper in an amount not to exceed \$2,500, and (4) Theatre and Arts Foundation of San Diego County dba La Jolla Playhouse in an amount not to exceed \$3,000, under terms and conditions set forth in the Agreements on file in the Office of the City Clerk as Document No. RR-314012-1 for Bodhi Tree Concert,

Document No. RR-314012-2 for La Jolla Art & Wine Foundation, Document No. RR-314012-4 for San Diego Coastkeeper, and Document No.

RR-314012-4 for Theatre and Arts Foundation of San Diego County dba La Jolla Playhouse.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$13,000 from Council District 1: Community Projects, Programs and Services budget Fund No. 100000, G/L Account No. 512059, Cost Center 1101110001, all to
