A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING \$6,300 TO I LOVE A CLEAN SAN DIEGO FOR A TECHNOLOGY UPGRADE, PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-06, titled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by San Diego Resolution R-306903 (July 7, 2011); and

WHEREAS, among other things, Council Policy 100-06 establishes guidelines and uniform eligibility requirements for funding Community Projects, Programs and Services with non-profit community organizations and public agencies for community, social, environmental, cultural, or recreational needs which serve a lawful public purpose; and

WHEREAS, I Love a Clean San Diego has requested funding for a technology upgrade; and

WHEREAS, the requested funding will be used to purchase new laptops, docking stations to sync laptops with in-office workspaces and the company's server, and IT labor to set up the laptops and install at each in-office work station; and

WHEREAS, I Love a Clean San Diego's request for funding for a technology upgrade will benefit the public by allowing it to remain current with its technology to ensure its staff can efficiently serve its regional constitutency; and

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-06; and

WHEREAS, Council Districts 2 and 5 recommend a total allocation of \$6,300 to the I Love a Clean San Diego for the purposes set forth in this resolution, attributed as follows:

Council District 2 – \$5,000 and Council District 5 – \$1,300; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocation described in this resolution is made for a public purpose.

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized and directed to execute, for and on behalf of the City, a Community Projects, Programs, and Services FY 2022 City Council Allocations Agreement between the City of San Diego and I Love a Clean San Diego (Agreement) in an amount not to exceed \$6,300 for the project described in this resolution, under terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No. RR-314014.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$5,000 from Council District 2: Community Projects, Programs and Services budget Fund No. 100000, G/L Account No. 512059, Cost Center 1102110002; and \$1,300 from Council District 5: Community Projects, Programs and Services budget Fund No. 100000, G/L Account No. 512059, Cost Center 1105110005, for a total of \$6,300, all to

provide funds for the above-referenced Agreement, contingent upon the Chief Financial Officer
first furnishing one or more certificates certifying that the funds necessary for expenditure are, or
will be, on deposit with the City Treasurer.
