A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING \$4,200 TO ELDERHELP OF SAN DIEGO FOR ITS SENIOR NUTRITION SERVICES PROGRAM, PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-06, titled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by San Diego Resolution R-306903 (July 7, 2011); and

WHEREAS, among other things, Council Policy 100-06 establishes guidelines and uniform eligibility requirements for funding Community Projects, Programs and Services with non-profit community organizations and public agencies for community, social, environmental, cultural, or recreational needs which serve a lawful public purpose; and

WHEREAS, ElderHelp of San Diego has requested funding for its Senior Nutrition Services Program; and

WHEREAS, the requested funding will be used to fund staff salaries to operate the program (which includes providing food insecurity consultations and referrals, developing a senior nutrition education webinar series or outreach program, procurement of food and supplies, and recruiting and managing volunteers), food pantry supplies (including bags, boxes, delivery carts, shelving, disinfectant cleaning supplies, and personal protective equipment such as masks and gloves as needed), purchase ads, print collateral material, and increase social media presence to increase the number of volunteers needed to assist with food deliveries, food pantry operations, and grocery shopping for seniors; and

WHEREAS, ElderHelp of San Diego's request for funding for its Senior Nutrition

Services Program will benefit the public by focusing food delivery efforts on senior housing

complexes of mobile home parks, thus scaling the program and expanding service areas to new

communities in the City of San Diego and introducing seniors to other ElderHelp of San Diego

services to ensure seniors can remain living independently in their homes; and

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-06; and

WHEREAS, Council Districts 2, 5, and 6 recommend a total allocation of \$4,200 to ElderHelp of San Diego for the purposes set forth in this resolution, attributed as follows:

Council District 2 – \$1,000; Council District 5 - \$1,200; and Council District 6 – \$2,000; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocation described in this resolution is made for a public purpose.

BE IT FURTHER RESOLVED, that the City Council waives Council Policy 100-06, section 3(g), which provides: "An organization may not apply to receive funding for an event or program which has already occurred, nor any capital improvement, goods, supplies, materials, or equipment which have already been purchased."

BE IT FURTHER RESOLVED, that the City Council waives Council Policy 100-06, section 8, which provides: "Community Projects, Programs and Services funding should be considered a one-time resource, and planned uses should be one-time in nature, to avoid service interruptions or employee impacts if funding is discontinued."

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized and directed to execute, for and on behalf of the City, a Community Projects, Programs, and Services FY 2022 City Council Allocations Agreement between the City of San Diego and ElderHelp of

San Diego (Agreement) in an amount not to exceed \$4,200 for the project described in this resolution, under terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No. RR-314020.

an amount not to exceed \$1,000 from Council District 2: Community Projects, Programs and Services budget Fund No. 100000, G/L Account No. 512059, Cost Center 1102110002; \$1,200 from Council District 5: Community Projects, Programs and Services budget Fund No. 100000, G/L Account No. 512059, Cost Center 1105110005; and \$2,000 from Council District 6: Community Projects, Programs and Services budget Fund No. 100000, G/L Account No. 512059, Cost Center 1105110005; and \$4,200, all to provide funds for the above-referenced Agreement, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
