A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO CONFIRMING AN APPOINTMENT TO THE LA JOLLA SHORES PLANNED DISTRICT ADVISORY BOARD.

WHEREAS, on May 30, 1974, the Council of the City of San Diego (City Council) adopted an ordinance, codified at San Diego Municipal Code section 1510.0105 (Municipal Code), creating the La Jolla Shores Planned District Advisory Board (Board); and

WHEREAS, the seven-member Board reviews permit applications referred to it, including applications for Planned Development Permits for residential development within the La Jolla Shores Planned District; submits recommendations or comments in writing to the City Manager; reviews any required Environmental Impact Reports prepared in conjunction with an application within the La Jolla Shores Planned District; and makes recommendations to the Planning Commission of any changes to regulations established for the La Jolla Shores Planned District; and

WHEREAS, the Municipal Code requires that Board members serve two-year terms and each member shall serve until a successor is duly appointed and qualified; and

WHEREAS, the Municipal Code requires that five members of the seven-member board shall be resident property owners of the La Jolla Shores Planned District; the sixth member shall be a resident of the district but need not own property; and the seventh member shall own property in the district but need not be a resident; and

WHEREAS, the Municipal Code requires that members of the Board shall be specifically qualified by reason of interest, training or experience in art, architecture, land development, landscape architecture, planning, urban design, or other relevant business or profession to judge

the effects of a proposed development upon the desirability, property values, and development of surrounding areas. At least one member of such Board shall be a registered architect in the State of California; and

WHEREAS, the Municipal Code requires that Board members be appointed by the Mayor and confirmed by the City Council; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the following appointment by the Mayor, to serve as a member of the La Jolla Shores Planned District Advisory Board, for a term ending as indicated, is made and hereby confirmed:
