A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO FOR APPROVING THE SETTLEMENT
AGREEMENT BETWEEN BEATRIZ ZARZA AND THE CITY
OF SAN DIEGO.

WHEREAS, on November 25, 2020, Plaintiff Beatriz Zarza filed this lawsuit for injuries allegedly caused by the dangerous condition of the road in the 900 block of 13th Street in San Diego when Plaintiff exited her car and stepped onto the edge of a large pothole, lost her balance and fell sustaining injuries on May 1, 2019; and

WHEREAS, in Closed Session on May 17, 2022, the City Council, by the following votes: Yeas, Districts 1, 2, 3, 4, 5, 6, 7, 8, and 9; Nays, None; and All Present, approved the Settlement for an amount consistent with the amounts set forth below; and

NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego:

1. Authorizes the Mayor or his designee to pay the sum of \$135,000.00 from Public Liability Fund No. 720045, in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorney fees, against City of San Diego, its agents and employees, arising from the personal injury complaint filed by Beatriz Zarza.

2. Authorizes the Chief Financial Officer to expend an amount not to exceed \$135,000.00 from Public Liability Fund No. 720045, for the purpose of settling this claim..
