A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING AMENDMENTS TO THE FISCAL YEAR 2023 BUDGET OF THE CITY OF SAN DIEGO.

WHEREAS, on June 17, 2022, the Mayor approved Resolution No. R-314153, approving the City of San Diego's Fiscal Year 2023 Budget (2023 Budget); and

WHEREAS, the 2023 Budget includes the annual budget for the Capital Improvement Program (CIP Budget); and

WHEREAS, on June 27, 2022, the Council of the City of San Diego (Council) approved the settlement (Settlement) of ongoing litigation involving certain real property located at 1200 Third Avenue and 101 Ash Street (collectively, the Properties); and

WHEREAS, in order to effectuate the Settlement pursuant to which the City of San Diego (City) will acquire the Properties, the 2023 Budget must be amended;

WHEREAS, the Office of the City Attorney has drafted this Resolution based on the information provided by City staff, with the understanding that this information is complete, true, and accurate; and

WHEREAS, the Council desires to approve the proposed budget amendments, appropriation changes and other actions as described below; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego that, contingent upon and effective immediately following the Council's adoption of the Fiscal Year 2023

Appropriation Ordinance, the following revisions to the 2023 Budget are approved and the

Chief Financial Officer is directed to adjust the Fiscal Year 2023 budget appropriations as follows:
