A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO AMENDING THE MIRAMAR BANNER
DISTRICT.

WHEREAS, San Diego Municipal Code section 142.1210(b)(5)(C) allows the placement of banners in public right of ways that are used for promoting cultural or civic events or activities of general public interest on streets and public rights-of-way designated by resolution of the City Council; and

WHEREAS, on December 16, 2016, by San Diego Resolution R-310839 (Resolution R-310839), the City Council authorized and established the Miramar Banner District; and

WHEREAS, under Resolution R-310839, the Mira Mesa Chamber of Commerce was identified as the sponsoring organization allowed to install banners on streets and in the public right-of-way for the Miramar Banner District; and

WHEREAS, the Mira Mesa Town Council is a non-profit corporation in operation for over 38 years and works to improve the Mira Mesa Community through civic engagement; and

WHEREAS, the Mira Mesa Town Council now wishes to sponsor the Miramar Banner District and install banners on streets and in the public right-of-way promoting cultural and civic events, and community activities of general public interest; and

WHEREAS, the City Council wishes to aid this civic endeavor; and

WHEREAS, the Office of the City Attorney has drafted this Resolution based on the information provided by City staff (including information provided by affected third parties and verified by City staff), with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that Resolution R-310839, adopted on December 16, 2016, is hereby amended to identify the Mira Mesa Town Council as the sponsoring organization for the Miramar Banner District, and allow the Mira Mesa Town Council to install banners in accordance with San Diego Municipal Code section 142.1210(b)(5)(C) and in the locations previously authorized and established by Resolution R-310839.
