A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO ADOPTING THE 2022 CLIMATE ACTION PLAN

WHEREAS, in 2008, the City adopted the 2008 General Plan, which contains policies related to conservation, sustainable growth, and resource management; and

WHEREAS, General Plan Policy CE-A.13 specifically provides for the City to “regularly monitor, update, and implement the City’s Climate ... Action Plan, to ensure, at a minimum, compliance with all applicable federal, state, and local laws”; and

WHEREAS, the 2015 Climate Action Plan (2015 CAP) was approved at the December 15, 2015 City Council meeting by adopting Resolution R-310175; and

WHEREAS, the 2015 CAP identified five strategies: (1) energy and water efficient buildings, (2) clean and renewable energy, (3) bicycling, walking, transit, and land use, (4) waste diversion, and (5) climate resiliency; and

WHEREAS, the 2015 CAP also included baseline GHG emissions for the year 2010, emissions reductions targets for the years 2020 and 2035, and forecasted emissions reductions from implementation of the strategies and actions identified in the 2015 CAP; and

WHEREAS, the City recognized in the 2015 CAP that it would be necessary to monitor and update the Climate Action Plan to achieve GHG reduction targets; and

WHEREAS, the 2015 CAP projected an update to occur in or around 2020; and

WHEREAS, in 2020, the City began implementing a community engagement plan and coordinated outreach efforts, in coordination with community-based organizations and non-profit

organizations, that resulted in feedback and contributions from more than 3,800 residents of diverse backgrounds and experiences; and

WHEREAS, the City partnered with the Building Electrification Institute and Inclusive Economics for a Workforce Impact Study to determine the impact of certain measures on various industries; and

WHEREAS, the 2022 Climate Action Plan (2022 CAP) establishes new goals, targets, and actions that exceed the goals set forth in the 2015 CAP; and

WHEREAS, the 2022 CAP identifies six strategies: (1) Decarbonization of the Built Environment, (2) Access to Clean and Renewable Energy, (3) Mobility and Land Use, (4) Circular Economy and Clean Communities, (5) Resilient Infrastructure and Healthy Ecosystems, and (6) Emerging Climate Actions; and

WHEREAS, the 2022 CAP has set a goal of net zero emissions by 2035; and

WHEREAS, the 2022 CAP includes a monitoring and reporting program, wherein the City will report on progress to the City Council and to the public through annual progress reports and comprehensive GHG emissions inventories at least every two years depending on data availability; and

WHEREAS, Ordinance No. 0-21528, which is considered along with this Resolution, amends the Land Development Code of the San Diego Municipal Code to add Climate Action Plan Consistency Regulations as part of the implementation measures for the CAP Update (CAP Consistency Regulations); and

WHEREAS, on June 30, 2022, the City Council Environment Committee voted 4-0 to recommend adoption of the Climate Action Plan with amendments; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. The 2022 Climate Action Plan, on file in the Office of the City Clerk as Document No. RR - **314297**, is hereby adopted.
2. The Mayor or designee is authorized to develop Climate Action Plan implementation plans informed by Council Policy on Climate Action Plan action prioritization.
3. The Mayor or designee is authorized to make minor administrative changes to the 2022 Climate Action Plan as necessary.
4. The 2022 Climate Action Plan shall take effect and be in force on the effective date of O - **21528**, which amends the San Diego Municipal Code to add the Climate Action Plan Consistency Regulations.
