

RESOLUTION NUMBER R- 314318DATE OF FINAL PASSAGE SEP 21 2022

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO DETERMINING THAT APPROVAL OF THE AS-NEEDED CURED-IN-PLACE PIPE (CIPP) LINING – FIVE YEAR AGREEMENT WITH SOUTHWEST PIPELINE & TRENCHLESS CORPORATION IS CATEGORICALLY EXEMPT FROM THE CALIFORNIA ENVIRONMENTAL QUALITY ACT PURSUANT TO CEQA GUIDELINES SECTIONS 15301(b) EXISTING FACILITIES AND 15302(c) RECONSTRUCTION.

WHEREAS, this action requests authorization and approval of the City Council of the City of San Diego (City Council) to execute a five-year As-Needed Agreement with Southwest Pipeline & Trenchless Corporation for an amount not to exceed \$3,791,250 for trenchless reconstruction services of the existing sewer gravity sewer mains and service laterals, by forming new pipes within existing deteriorated pipes (Project); and

WHEREAS, the California Environmental Quality Act (CEQA) (Public Resources Code section 21000 et seq.), section 21084, states that the CEQA Guidelines thereto (California Code of Regulations, Title 14, Chapter 3, section 15000 et seq.) shall list those classes of projects which have been determined not to have a significant effect on the environment and which shall be exempt from CEQA; and

WHEREAS, under that authority, CEQA Guidelines sections 15300-15333 list the categorical exemptions promulgated by the California Office of Planning and Research and adopted by the Secretary of the California Natural Resources Agency for those classes of projects which have been determined not to have a significant effect on the environment; and

WHEREAS, the City's Planning Department has established that the Project is categorically exempt from CEQA under CEQA Guidelines section 15301(b) (Existing Facilities), and categorically exempt from CEQA under CEQA Guidelines section 15302(c)

(Reconstruction), and that no exceptions to the exemptions, as set forth in CEQA Guidelines section 15300.2, apply to the Project; and

WHEREAS, the City Council held a duly noticed public meeting, and has considered the potential environmental effects of the Project, and the written and verbal testimony and evidence presented at or before the public hearing, regarding the subject matter of this Resolution; and

WHEREAS, the Council of the City of San Diego, using its independent judgment, has determined that the Project will not have a significant effect on the environment under CEQA Guidelines section 15301(b) (Existing Facilities), or under CEQA Guidelines section 15302(c) (Reconstruction), because the area in which the Project is located consists of trenchless relining of pipelines in existing infrastructure, adds no new facilities, reconstructs existing pipelines, and is not environmentally sensitive; and

WHEREAS, the Office of the City Attorney has drafted this resolution based on the information provided by City staff including information provided by affected third parties and verified by City staff, with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the Project is categorically exempt from CEQA, under CEQA Guidelines section 15301(b) (Existing Facilities) and categorically exempt from CEQA, under CEQA Guidelines section 15302(c) (Reconstruction), because the area in which the Project is located consists of trenchless relining of pipelines in existing infrastructure, adds no new facilities, reconstructs existing pipelines, and is not environmentally sensitive.

2. That the Council of the City of San Diego has determined that an exception to the exemption as set forth in CEQA Guidelines section 15300.2 would not apply.






