A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE APPLICATION FOR ENVIRONMENTAL MITIGATION LAND MANAGEMENT GRANT PROGRAM FUNDS, AND ALL RELATED ACTIONS, FOR THE DENNERY CANYON RARE PLANT RESOTRATION, OTAY MESA VERNAL POOL RESTORATION, AND WEST OTAY MESA STINKNET REMOVAL PROJECTS.

WHEREAS, in November 2004 the voters of San Diego County approved San Diego Association of Government's (SANDAG) Ordinance 04-01, which extended the *TransNet* ½ cent sales and use tax through 2048 (*TransNet* Ordinance); and

WHEREAS, the *TransNet* Ordinance contains provisions for the creation of an Environmental Mitigation Program (EMP), which began being funded by the *TransNet* Ordinance on April 1, 2008; and

WHEREAS, on October 25, 2021 SANDAG issued its Cycle 10 call for projects from entities wishing to apply for a portion of the EMP Regional Habitat Conservation grant funds for use on environmental land management projects meeting certain criteria; and

WHEREAS, the City of San Diego (City) wishes to receive \$336,085 in EMP Regional Habitat Conservation grant funding for rare plant focused habitat restoration in Dennery Canyon, \$80,000 for vernal pool restoration in Goat Mesa and Wruck Canyon, and \$80,000 for controlling the spread of an invasive plant known as stinknet in the Otay Mesa area (Projects); and

WHEREAS, the City understands that EMP grant funding is fixed at the programmed amount, and therefore Project cost increases that exceed the grant awarded will be the sole responsibility of the City; and

WHEREAS, the Office of the City Attorney has drafted this resolution based on the information provided by City staff, with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Mayor, or the Mayor's designee, is authorized to make an application to San Diego Association of Government's (SANDAG) EMP Regional Habitat Conservation fund (Grant) for \$336,085 for rare plant focused habitat restoration in Dennery Canyon, \$80,000 for vernal pool restoration in Goat Mesa and Wruck Canyon, and \$80,000 for controlling the spread of an invasive plant known as stinknet in the Otay Mesa area (Projects).

BE IT FURTHER RESOLVED, that if a Grant award is made by SANDAG to fund the Dennery Canyon Project, City of San Diego commits to providing matching funds and/or in-kind contributions in an amount not to exceed \$50,826 over three years.

BE IT FURTHER RESOLVED, that the Mayor, or the Mayor's designee, is authorized to conduct all negotiations, sign, and submit all documents, including, but not limited to, the Grant Agreement included in the Cycle 10 call for projects with SANDAG without exceptions, applications, agreements, amendments, and payment requests, which may be necessary for the completion of the grant's scope of work.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to accept, appropriate, and expend an amount not to exceed \$496,085 in Grant Program funding for the Projects, if the grant funding is secured, and contingent upon the Chief Financial Officer furnishing one or more certificates that funds are, or will be, on deposit with the City Treasurer.

BE IT FURTHER RESOLVED, that if any grant funding discussed above is secured, the Chief Financial Officer is authorized to establish a special interest-bearing account for such grant, if required.
