A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING EXECUTION OF AN AGREEMENT WITH ALLSTAR FIRE EQUIPMENT, INC. FOR THE PURCHASE OF PERSONAL PROTECTIVE EQUIPMENT.

WHEREAS, structure Personal Protective Equipment (PPE) is a firefighter's first line of defense against fire; and

WHEREAS, the San Diego Fire-Rescue Department issues two sets of PPE for every firefighting position in Emergency Operations; and

WHEREAS, standard structure PPE is designed to protect a firefighter from extreme heat, moisture, and trauma, enabling a firefighter to safely attack fire while remaining safe from injury; and

WHEREAS, the Lion PPE ensemble to be purchased under this agreement includes a complete set of PPE and new design features which will increase firefighter safety and comfort; and

WHEREAS, this five-year agreement for an amount not to exceed \$8,930,067.67 will allow the purchase of 1,080 Lion PPE ensembles for the next 15 Fire Academies, totaling 540 recruits. In addition, this agreement will allow the purchase of up to 1,275 Lion PPE ensembles to replace expired or damaged equipment over the next five years; and

WHEREAS, the Lion PPE sold by Allstar Fire Equipment are built to the custom safety specifications of the Fire-Rescue Department for the protection of Fire-Rescue personnel; and

WHEREAS, some of these custom design features are proprietary to Lion PPE only (ISO Dry Moisture Barrier and Center Cut Liner); and

WHEREAS, these specifications also meet or in many cases exceed the National Fire Protection Agency 1971 standards for PPE; and

WHEREAS, this new agreement will ensure the continued safety of the City's firefighting personnel; and

WHEREAS, on July 11, 2022, the Purchasing and Contracting Director approved a Sole Source Request for this agreement with Allstar Fire Equipment, Inc.; and

WHEREAS, the Office of the City Attorney has drafted this resolution based on the information provided by City staff, with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Mayor, or his designee is authorized to execute, for and on behalf of the City, a five-year agreement with Allstar Fire Equipment Inc. in an amount not to exceed \$8,930,067.67 to purchase firefighting personal protective equipment, on file with the City Clerk as Document No. RR-

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$8,930,067.67 from the Fire-Rescue Department General Fund, over the five-year term of the agreement to purchase firefighting personal protective equipment, contingent upon the adoption of the Annual Appropriation Ordinance for the applicable fiscal

year and contingent upon the Chief Financial Officer furnishing	ng one or more certificates

Treasurer.
