A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO DETERMINING AWARD OF A CONSULTANT CONTRACT TO SILLMAN WRIGHT ARCHITECTS FOR THE PROFESSIONAL DESIGN AND CONSTRUCTION SUPPORT SERVICES OF EMTS NTC LABORATORY REMODEL AND NTC LAB SOLAR IMPLEMENTATION PROJECT LOCATED AT 2392 KINCAID ROAD, SAN DIEGO, CA 92106, IS STATUTORILY EXEMPT FROM CALIFORNIA ENVIRONMENTAL QUALITY ACT PURSUANT TO CEQA GUIDELINES SECTION 15262.

WHEREAS, the Council of the City of San Diego is considering approval of a consultant agreement with Sillman Wright Architects for professional design and construction support services of Environmental Monitoring and Technical Services (EMTS), Naval Training Center (NTC) Laboratory Remodel and NTC Laboratory Solar Implementation Project located at 2392 Kincaid Road, San Diego, CA 92106 (Project); and

WHEREAS, the California Environmental Quality Act (CEQA) (Public Resources Code section 21000 et seq.), section 21084, states that the CEQA Guidelines thereto (California Code of Regulations, Title 14, Chapter 3, Section 15000 et seq.) adopted by the California Office of Planning and Research pursuant to Public Resources Code Section 21083, shall list those classes of projects which have been determined not to have a significant effect on the environment and which shall be exempt from CEQA; and

WHEREAS, pursuant to the authority, CEQA Guidelines section 15260 through 15285 list the statutory exemptions promulgated by the California State Legislature; and

WHEREAS, the project is statutorily exempt from CEQA pursuant to CEQA Guidelines section 15262 (entitled "Feasibility and Planning Studies") which exempts a project from CEQA

involving only feasibility and planning studies for possible future actions which the agency, board, or commission has not approved, adopted, or funded; and

WHEREAS, the Council of the City of San Diego considered the potential effect of the consultant contract; and

WHEREAS, the Council of the City of San Diego held a duly noticed public meeting and considered the written record for the Project as well as public comment; and

WHEREAS, the Office of the City Attorney has drafted this resolution based on the information provided by City staff, with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,

BE IT RESOLVED, that the Council of the City of San Diego determines this Project is statutorily exempt from CEQA pursuant to CEQA Guidelines section 15262 which exempts a project involving only feasibility and planning studies for possible future actions which the agency, board, or commission has not approved, adopted, or funded.






