A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO AUTHORIZING EXECUTION OF AN
AGREEMENT WITH SAN DIEGO POLICE EQUIPMENT
COMPANY, INC. FOR THE PURCHASE OF AMMUNITION.

WHEREAS, the San Diego Police Department (Department) requires ammunition for handgun, shotgun and rifle range shootings, qualification shoots, and Department trainings; and

WHEREAS, Invitation to Bid (ITB) No. 10089921-22-B for the purchase of ammunition was issued by the Purchasing and Contracting Department on June 6, 2022; and

WHEREAS, San Diego Police Equipment Company, Inc. (San Diego Police Equipment) was the lowest responsive and responsible bidder, and was awarded the Contract, contingent on City Council approval; and

WHEREAS, the City of San Diego and San Diego Police Equipment desire to enter into a five (5) year Contract in an amount not to exceed \$5,394,176 over the full five-year term; and

WHEREAS, Contract payments are estimated to be \$976,210 in Fiscal Year (FY) 2023, \$1,025,021 in FY 2024, \$1,076,271 in FY 2025, \$1,130,085 in FY 2026, and \$1,186,589 in FY 2027; and

WHEREAS, the Office of the City Attorney has drafted this resolution based on the information provided by City staff, with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Mayor, or his designee, is authorized to execute, for and on behalf of the City, the Contract between the City and San Diego Police Equipment to purchase ammunition, in an amount not to exceed

\$5,394,176 over the five-year term of the Contract, under the terms and conditions set forth in the Contract, on file in the Office of the City Clerk as Document No. RR- 314363.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to appropriate and expend an amount not to exceed \$5,394,176 from the General Fund (100000), over the five (5) year term of the Contract with San Diego Police Equipment for the purchase of ammunition, contingent upon the adoption of the Annual Appropriation Ordinance for the applicable fiscal year and contingent upon the Chief Financial Officer furnishing a certificate certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
