A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO APPROVING A SIDE LETTER AGREEMENT
BETWEEN THE CITY AND THE SAN DIEGO MUNICIPAL
EMPLOYEES ASSOCIATION TO AMEND ARTICLE 44 OF
THE MEMORANDUM OF UNDERSTANDING RELATED TO
UNIFORM ALLOWANCE FOR THE SENIOR CODE
COMPLIANCE SUPERVISOR CLASSIFICATION.

WHEREAS, by San Diego Resolution R-313568 (June 11, 2021), the San Diego City Council (Council) approved a Memorandum of Understanding (MOU) between the City of San Diego (City) and the San Diego Municipal Employees Association (MEA) that establishes terms and conditions of employment for MEA-represented employees; and

WHEREAS, Article 44 of the MOU provides a uniform allowance per fiscal year for the Code Compliance Officer and Code Compliance Supervisor classifications in the Fire-Rescue Department; and

WHEREAS, the Fire Rescue Department added a Senior Code Compliance Supervisor to its Fiscal Year 2023 budget. This classification requires a uniform similar to the other positions within the classification series in the Fire-Rescue Department; and

WHEREAS, the City and MEA reached a tentative agreement to amend Article 44 of the MOU by adding the Senior Code Compliance Supervisor to the list of classifications eligible for uniform allowance during the term of the MOU; and

WHEREAS, the terms of the tentative agreement are provided in the Side Letter Agreement (Agreement) on file in the Office of the City Clerk as Document No. RR- **314385**
and

WHEREAS, the Agreement must be approved by a two-thirds majority vote of the Council to take effect, in accordance with San Diego Charter section 11.2; and

WHEREAS, the Office of the City Attorney has drafted this resolution based on the information provided by City staff, with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Council approves the Agreement between the City and MEA to amend Article 44 of the MOU related to uniform allowance for the Senior Code Compliance Supervisor classification, which is on file in the Office of the City Clerk as Document No. RR- 314385.
