A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE FINAL SETTLEMENT BETWEEN BIANCA RUFFINO, AND THE CITY OF SAN DIEGO.

WHEREAS, on August 3, 2020, Plaintiff Bianca Ruffino filed suit against the City of San Diego, et al. alleging personal injuries from a bicycle crash that occurred on June 28, 2019, when she was riding her bike west on Santa Clara Place when she struck an uneven, cracked and potholed section of pavement which caused her bike to fall. The suit is entitled *Ruffino, Bianca v. City of San Diego*, San Diego Superior Court Case No. 37-2020-00027052-CU-PO-CTL ("the Litigation"); and

WHEREAS, in closed session on July 19, 2022, the San Diego City Council, by the following votes: Yeas, Districts 1, 2, 3, 4, 5, 6, 7, 8, and 9; Nays, none; Absent, none, approved the settlement of the Litigation for an amount consistent with the amounts set forth below and pursuant to such other terms more fully set forth in the Settlement Agreement; and

WHEREAS, the Office of the City Attorney has drafted this resolution based on the information provided by City staff including information provided by affected third parties and verified by City staff, with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Council:

1. Authorizes the Mayor or his designee to pay the sum of \$170,000 from Public Liability Fund No. 720045, in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorney fees, against City of San Diego, its agents and employees, arising from the personal injury claim of Bianca Ruffino; and

2.	Authorizes the Chief Financial Officer to e	xpend an amount not to exceed \$170,000
from F	Public Liability Fund No. 720045, for the pu	rpose of settling this claim.
