A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO APPROVING THE SETTLEMENT AGREEMENT
BETWEEN ADELE PILISZEK AND THE CITY OF SAN
DIEGO

WHEREAS, on November 13, 2018, Adele Piliszek filed suit against the City of San Diego alleging personal injuries arising from a December 11, 2017 bicycle accident in the bike lane at, or about, 10280 North Torrey Pines Road, in the City of San Diego. The suit is captioned *Adele Piliszek v. City of San Diego*, San Diego Superior Court Case No. 37-2018-00057178-CU-PO-CTL; and,

WHEREAS, in Closed Session on September 20, 2022, the City Council, by the following votes: Yeas, Districts 1, 2, 3, 4, 5, 6, 7 and 9; Nays, None; and one absent, District 8, approved the Settlement for an amount consistent with the amounts set forth below;

NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the City Council:

- 1) Authorizes the Mayor or his designee to pay the sum of \$250,000 from Public Liability Fund No. 720045, in settlement of each and every claim for damages, interest, costs and fees of any type, including attorney fees, against the City of San Diego, its agents and employees, arising from the personal injury complaint filed by Plaintiff Adele Piliszek.

2) Authorize the Chief Financial Officer to expend an amount not to exceed \$250,000 from Public Liability Fund No. 720045, for the purpose of settling this claim.
