DATE OF FINAL PASSAGE NOV 03 2022

A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO CONFIRMING THE APPOINTMENT AND
SALARY OF ERIC DARGAN AS CITY MANAGER (CHIEF
OPERATING OFFICER).

WHEREAS, San Diego Charter section 265 sets forth the duties of the City of San Diego
(City)'s Mayor; and

WHEREAS, San Diego Charter section 265(b)(7) states that the Mayor has “[s]ole
authority to appoint the City Manager, subject to Council confirmation”; and

WHEREAS, the City Manager is commonly referred to as the City’s Chief Operating
Officer; and

WHEREAS, Mayor Gloria appointed Jay Goldstone as the interim Chief Operating
Officer, effective February 1, 2021, pending appointment of a permanent Chief Operating
Office; and

WHEREAS, Mayor Gloria appointed Eric Dargan to the permanent Chief Operating
Officer position, effective November 1, 2022; and

WHEREAS, on September 12, 2022, the City Council unanimously confirmed the
appointment of Eric Dargan as the Chief Operating Officer of the City; and

WHEREAS, Mayor Gloria has supervisory authority over the Chief Operating Officer, in
accordance with San Diego Charter section 265(b)(7), and the authority to set the compensation
for the Chief Operating Officer, in accordance with San Diego Charter sections 28 and 70, so
long as the compensation is within the salary rates for the position as established by the City
Council in adopting the annual Salary Ordinance; and

WHEREAS, as required by state law, the City Council now wishes to confirm the appointment of Eric Dargan as Chief Operating Officer of the City at a salary of \$375,000 per year, with management level fringe benefits as described in the City's annual Salary Ordinance; and

WHEREAS, the Office of the City Attorney has drafted this resolution based on the information provided by City staff, with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,

BE IT RESOLVED by the Council of the City of San Diego that the City Council confirms the appointment of Eric Dargan to the position of City Manager, which is also known as Chief Operating Officer, effective November 1, 2022, at a salary of \$375,000 per year, with management level fringe benefits as described in the City's annual Salary Ordinance.
