A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE SETTLEMENT AGREEMENT BETWEEN GREGORY MONTOYA, ET AL. AND THE CITY OF SAN DIEGO.

WHEREAS, on September 5, 2019, Plaintiffs Gregory Montoya, Julie Staffiero, Frank Staffiero, Yasser Jaber, Carla Jaber, Nicholas Martinez, and Teresa Martinez filed suit against the City of San Diego, alleging property damage from flooding on December 6, 2018, and prior storms, because a public improvement changed the direction of the natural water course and increased the flow of water towards their homes. The suit is entitled *Gregory Montoya*, et al. v. City of San Diego, San Diego Superior Court Case No. 37-2019-00047134-CU-EI-CTL (Litigation); and

WHEREAS, in closed session on October 11, 2022, the San Diego City Council, by the following votes: Yeas, Districts 1, 2, 3, 4, 5, 6, 7, and 9; Nays, none; Absent 8, approved the settlement of the Litigation for an amount consistent with the amounts set forth below and pursuant to such other terms more fully set forth in the Settlement Agreement; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Council:

1. Authorizes the Mayor or his designee to pay the sum of \$209,000 from Public Liability Fund No. 720045, in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorney fees, against City of San Diego, its agents and employees, arising from the Litigation.

2. Authorizes the Chief Financial Officer to expend an amount not to exceed							
\$209,000 from Public Liability Fund No.	720045, for purpose of settling the Litigation.
