A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO APPROVING THE SETTLEMENT BETWEEN
TINA PATTERSON AND THE CITY OF SAN DIEGO

WHEREAS, on July 24, 2018, Tina Patterson filed a lawsuit against the City of San Diego (City) alleging damages arising from her employment with the City, entitled *Tina Patterson v. City of San Diego, et al.*, San Diego Superior Court Case No. 37-2018-00037189-CU-OE-CTL;


WHEREAS, in Closed Session on September 13, 2022, the City Council, by the following votes: Yeas, District(s) 1, 2, 3, 4, 5, 6, 7, and 9; Nays, none; and absent, 8, approved the Settlement for an amount consistent with the amounts set forth below; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego that the Council:

1. Authorizes the Mayor or his designee to pay the sum of \$88,000.00 from Water Fund No. 700011, in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorney fees, against the City, its agents and employees, arising from Tina Patterson's employment with the City of San Diego asserted in the lawsuit entitled *Tina Patterson v. City of San Diego, et al.*, San Diego Superior Court Case No. 37-2018-00037189-CU-OE-CTL.

2. Authorizes the Chief Financial Officer to expend an amount not to exceed \$88,000.00 from Water Fund No.700011, for the purpose of settling this claim.
