A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO APPROVING THE SETTLEMENT AGREEMENT
BETWEEN STEPHANIE SCUDDER AND THE CITY OF SAN
DIEGO

WHEREAS, on November 16, 2020, Stephanie Scudder filed suit against the City of San Diego alleging personal injuries arising from a December 8, 2019, trip and fall on the sidewalk at 1454 Garnet Avenue, in the City of San Diego. The suit is captioned *Stephanie Scudder v. City of San Diego*, San Diego Superior Court Case No. 37-2020-00041883-CU-PO-CTL; and,

WHEREAS, in Closed Session on October 11, 2022, the San Diego City Council, by the following votes: Yeas, Districts 1, 2, 3, 4, 5, 6, 7 and 9; Nays, None; and one absent, District 8, approved the Settlement for an amount consistent with the amounts set forth below;

NOW, THEREFORE, BE IT RESOLVED, by the Council of the City of San Diego, that the Council:

- 1) Authorizes the Mayor or his designee to pay the sum of \$225,000.00 from Public Liability Fund No. 720045, in settlement of each and every claim for damages, interest, costs and fees of any type, including attorney fees, against the City of San Diego, its agents and employees, arising from the personal injury complaint filed by Plaintiff Stephanie Scudder.

2) Authorizes the Chief Financial Officer to expend an amount not to exceed \$225,000.00 from Public Liability Fund No. 720045, for the purpose of settling this claim.
