A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO AUTHORIZING THE MAYOR, OR DESIGNEE,
TO EXECUTE A FIRST AMENDMENT TO THE
AGREEMENT WITH PEOPLE ASSISTING THE HOMELESS
SAN DIEGO (PATH SAN DIEGO) FOR COORDINATED
STREET OUTREACH PROGRAM SERVICES AND RELATED
ACTIONS.

WHEREAS, in July 2022, the City of San Diego entered into an Agreement for
Coordinated Street Outreach Program Services (Contract) with People Assisting the Homeless
San Diego (PATH San Diego), the successful proposer to a Request for Proposals for coordinate
street outreach services issued by the City in April 2022; and

WHEREAS, the City's Coordinated Street Outreach Program (Program) incorporates
nationally recognized best practices and a neighborhood-based, person-centered approach to
meet the needs of the City's unsheltered population; and

WHEREAS, the Program actively engages individuals and households experiencing
homelessness by focusing outreach resources; and

WHEREAS, PATH San Diego operates two types of response teams: (1) mobile response
teams that work to locate and engage people identified as the most vulnerable and who are
prioritized for resources, and (2) rapid response teams that focus on areas of high concentration
and respond to community referrals providing immediate intervention and problem-solving
activities; and

WHEREAS, the City now desires to increase PATH San Diego's budget by \$475,000
and amend the Contract's scope of work to provide flexible funds for client support that PATH
San Diego will disburse based on referrals from community-based agencies requesting support
funds on behalf of individuals experiencing homelessness; and

WHEREAS, the client support funds consist of \$350,000 from Homeless Housing, Assistance, and Prevention (HHAP) Round 2 funds and \$125,000 from HHAP Round 1 funds; and

WHEREAS, on October 20, 2022, the Land Use and Housing Committee recommended the First Amendment to the Contract with PATH San Diego be forwarded to the Council of the City of San Diego; NOW, THEREFORE,

WHEREAS, the Office of the City Attorney has drafted this resolution based on the information provided by City staff, with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Mayor, or his designee, is authorized to execute a First Amendment to the Agreement with People Assisting the Homeless San Diego (PATH San Diego) to increase the budget by an additional \$475,000 and amend the Scope of Work.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$350,000 in HHAP Round 2 funds and \$125,000 in HHAP Round 1 funds to be allocated to PATH San Diego for the Coordinated Street Outreach Program.
