A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO AUTHORIZING THE MAYOR, OR DESIGNEE,
TO EXECUTE THE FIRST AMENDMENT TO THE
AGREEMENT WITH THE DOWNTOWN SAN DIEGO
PARTNERSHIP FOUNDATION FOR FAMILY
REUNIFICATION PROGRAM SERVICES.

WHEREAS, Council of the City of San Diego (Council) approved an Agreement for
Family Reunification Program Services (Agreement) between the City and Downtown San
Diego Partnership Foundation by Resolution R-314190 (Jun. 23, 2022); and

WHEREAS, the Family Reunification Program is a hybrid outreach, services, and
rehousing program that reconnects individuals experiencing homelessness with their families and
loved ones willing to provide stable living environments and helps participants build support
systems and establish links to long-term housing; and

WHEREAS, the City and Downtown San Diego Partnership Foundation now desire to
amend the Agreement to add outreach services in alignment with the City's Coordinated Street
Outreach Program and the outreach standards adopted by the Regional Task Force on
Homelessness and make other technical corrections to the Agreement; and

WHEREAS, on October 20, 2022, the Land Use and Housing Committee recommended
the First Amendment to the Agreement with Downtown San Diego Partnership Foundation be
forwarded to the Council; and

WHEREAS, the Office of the City Attorney has drafted this resolution based on the
information provided by City staff, with the understanding that this information is complete, true,
and accurate; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Mayor, or designee, is authorized to execute a First Amendment to the Agreement with Downtown San Diego Partnership for the Family Reunification Program.
