The suit is entitled *Estate of Timothy Gene Smith, et al. v. City of San Diego, et al.*, United States District Court Case No. 16cv2989 WQH (MSB) (Litigation); and

WHEREAS, in closed session on October 18, 2022, the San Diego City Council, by the following votes: Yeas, Districts 2, 4, 5, 6, 7, and 9; Nays, none; Absent Districts 1 and 8; Recused District 3, and approved the settlement of the Litigation for an amount consistent with the amounts set forth below and pursuant to such other terms more fully set forth in the Settlement Agreement; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Council:

1. Authorizes the Mayor or his designee to pay the sum of \$495,000 from Public Liability Fund No. 720045, in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorney fees, against the City of San Diego and its agents and employees, arising from the Litigation.
