A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO APPROVING THE SETTLEMENT AGREEMENT
BETWEEN GLORIA RICHLEY AND THE CITY OF SAN
DIEGO.

WHEREAS, on June 6, 2019, Gloria Richley filed a suit against the City of San Diego alleging personal injuries arising from a March 14, 2019, trip and fall on the sidewalk at 3493 Larga Circle, in the City of San Diego. The suit is captioned *Gloria Richley v. City of San Diego*, San Diego Superior Court Case No. 37-2019-00045689-CU-PO-CTL; and

WHEREAS, in Closed Session on September 13, 2022, the San Diego City Council, by the following votes: Yeas, Districts 1, 2, 3, 4, 5, 6, 7 and 9; Nays, None; and one absent, District 8, approved the Settlement for an amount consistent with the amounts set forth below;

NOW, THEREFORE, BE IT RESOLVED, by the Council of the City of San Diego, that the Council:

1. Authorizes the Mayor or his designee to pay the sum of \$350,000 from the Public Liability Fund No. 720045, in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorney fees, against City of San Diego, its agents and employees, arising from the personal injury complaint filed by Plaintiff Gloria Richley.

2. Authorizes the Chief Financial Officer to expend an amount not to exceed \$350,000 from the Public Liability Fund No. 720045, for the purpose of settling this claim.
