A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO AMENDING THE 2023 LEGISLATIVE
CALENDAR.

WHEREAS, each year, the Council of the City of San Diego (Council) adopts a schedule of meetings for the calendar year for the Council and its Standing Committees, commonly referred to as the legislative calendar; and

WHEREAS, the legislative calendar also includes the meetings of the Budget Review Committee, the Housing Authority, and the Public Facilities Financing Authority; and

WHEREAS, on November 1, 2022, the Council adopted the 2023 Legislative Calendar, on file in the Office of the City Clerk as Document No. R-2023-213; and

WHEREAS, San Diego Municipal Code section 22.0101 allows the Council to adopt a resolution that changes, when necessary, the time and place of a regular meeting and sets forth the circumstances necessitating the change; and

WHEREAS, on November 14, 2022, the Council discussed and approved the addition of another standing committee, as well as changing the Council and Closed Session meeting times; and

WHEREAS, the Council President proposes to amend the 2023 Legislative Calendar, to accommodate these changes; and

WHEREAS, the proposed amendments to the 2023 Legislative Calendar will:

1. Remove Closed Session Tuesday meetings at 10am
2. Add Closed Session meetings on Mondays at 10am
3. Add City Council meetings on Mondays at 10am
4. Revise all Public Safety and Livable Neighborhood (PS&LN) Committee meetings to be Public Safety (PS) Committee
5. Add the meetings for Community and Neighborhood Services (CNS Committee)

WHEREAS, the Office of the City Attorney has drafted this resolution based on the information provided by City staff, with the understanding that this information is complete, true, and accurate; and

WHEREAS, under San Diego Charter section 280(a)(1), this resolution is not subject to veto by the Mayor, because this matter is exclusively within the purview of the Council and does not affect the administrative service of the City under the control of the Mayor; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the 2023 Legislative Calendar is hereby amended as reflected in the amended 2023 Legislative Calendar, a copy of which is on file in the Office of the City Clerk as Document No. RR- 314513.
