A RESOLUTION OF THE COUNCIL OF THE CITY OF  
SAN DIEGO AMENDING COUNCIL POLICY NO. 000-32.

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 000-32, "Neighborhood Input on Infrastructure Needs and Priorities" on July 5, 2013 to establish guidelines for the City to engage with San Diegans to collect input about neighborhood infrastructure needs; and

WHEREAS, Council Policy 000-32 also establishes the framework for neighborhood input on infrastructure needs and priorities for consideration in the City's Capital Improvement Program (CIP); and

WHEREAS, the City Council desires to amend Council Policy 000-32 to support delivering infrastructure to San Diegans based on community needs and expected service levels; and

WHEREAS, the proposed amendments focus on community education on the CIP budget process and gathering neighborhood input on the City's CIP budget based on equitable community engagement including community-based organizations, community planning groups, and other interested stakeholders and individuals, with focused engagement within the City's underserved communities, and

WHEREAS, the amendments to Council Policy 000-32 included in the staff materials accompanying this resolution are proposed for approval; and

WHEREAS, the Office of the City Attorney has drafted this resolution based on the information provided by City staff, with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that Council Policy 000-32, entitled "Neighborhood Input on Infrastructure Needs and Priorities" is amended and replaced with the document on file in the Office of the City Clerk as Document No. RR-
