A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO AUTHORIZING A NINTH EXTENSION TO THE
AGREEMENT WITH ALLAN COMPANY TO OPERATE THE
MIRAMAR LANDFILL RECYCLING CENTER.

WHEREAS, in 2001, the San Diego City Council (City Council) authorized execution of an agreement with Allan Company to operate the City's recycling center at the Miramar Landfill, which Agreement is on file in the Office of the City Clerk as Document Number RR-295859 (Agreement); and

WHEREAS, pursuant to the Agreement, the City Council by resolution authorized eight previous extensions to the Agreement, the term of which currently ends December 31, 2022; and

WHEREAS, in accordance with the Agreement, the parties wish to extend the Agreement a ninth time for a period of four years, until December 31, 2026; and

WHEREAS, on November 21, 2022, the Environment Committee recommended approval of this item; and

WHEREAS, the Office of the City Attorney has drafted this Resolution based on the information provided by City staff, with the understanding that this information is complete, true, and accurate; NOW THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego (City), that the Mayor or his designee is authorized to execute, for and on behalf of the City, a ninth extension to the Agreement with Allan Company for the operation of the Miramar Landfill Recycling Center, under the terms and conditions set forth in the Ninth Amendment to the Miramar Recycling

Center Service Contract/Real Property Lease, on file with the City Clerk as Document No. RR
