A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO RATIFYING OF SEVENTEEN (17) ENGINEERING AND CAPITAL PROJECTS FISCAL YEAR 2022 EMERGENCY SOLE SOURCE CONTRACTS.

WHEREAS, this action of the Council of the City of San Diego (City Council) is to ratify seventeen (17) Engineering and Capital Projects Fiscal Year 2022 emergency sole source contracts pursuant to section 22.3108 of the San Diego Municipal Code (Municipal Code); and

WHEREAS, in Fiscal Year 2022, the City initiated seventeen (17) emergency sole source contracts to provide repairs to failures that included structure, drainage systems, water systems, and wastewater systems; and

WHEREAS, for each of these instances, the Engineering and Capital Projects

Department issued a memo notifying the City Council of the emergency condition along with the location, type of failure, estimated cost, and other preliminary information available at the time that the problem was encountered; and

WHEREAS, pursuant to Section 22.3108 of the Municipal Code, Engineering and Capital Projects contracts may be awarded without advertisement to address public safety and health issues due to extraordinary fire, flood, storm, and other disasters, provided that the Mayor immediately reports the emergency award to the City Council and the City Council subsequently ratifies the award by resolution of a two-thirds vote; and

WHEREAS, in order to respond to such unforeseen emergency conditions, the

Engineering and Capital Projects Department maintains a list of Pre-Qualified As-Needed

Contractors previously approved to perform emergency repairs and related construction services,

when requested by the various asset managing departments and determined by the City Engineer to fall within the parameters of emergency conditions set forth in the code; and

WHEREAS, the Office of the City Attorney has drafted this resolution based on the information provided by City staff with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,
