A RESOLUTION OF THE COUNCIL OF THE CITY OF  
SAN DIEGO AWARDING A CONTRACT TO MIDWEST  
TAPE, LLC TO PROVIDE AUDIO/VISUAL MATERIALS  
AND PROCESSING SERVICES.

WHEREAS, the City of San Diego (City) requires books and audio/visual materials to maintain current and comprehensive circulating and reference collections for use by the public through its Library Department, the San Diego Public Library (Library), and, such materials also require processing services to prepare books and audio/visual materials for use by the public such as applying dust covers, spine labels, RFID book tags, barcode labels, genre labels, property stamps, and cases or packaging as necessary; and

WHEREAS, the Library solicited bids for such materials and services through Invitation to Bid No. 1008900-22-R; and

WHEREAS, all received bids were evaluated to determine the lowest responsive and responsible bidders to provide those materials and services to the City; and two bidders were recommended for award: one for books and related processing services, and the other for audio/visual materials and related processing services; and

WHEREAS, Midwest Tape, LLC, is recommended for award to provide audio/visual materials and related processing services for public use, as needed, for a period of five years, with a total amount not to exceed \$2,500,000; and

WHEREAS, the Office of the City Attorney has drafted this resolution based on the information provided by City staff, with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Mayor or the Mayor's designee is authorized to execute an agreement with Midwest Tapes, LLC (Bid No. 10089900-22-R) for the as-needed purchase of audio/visual materials and related processing services, for an amount not to exceed \$2,500,000 over a period of five years.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$2,500,000 in total from the Library Department, General Fund, for the purpose of funding the above agreement, and that such expenditure may be offset by use of the Library Donations Matching Fund as approved by the Library Department, contingent up on the adoption of the Annual Budget and Annual Appropriation Ordinances for the applicable fiscal years and contingent upon the Chief Financial Officer certifying that the funds for expenditure are or will be available.
