A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO TO APPROVE FISCAL YEAR 2023 CITY COUNCIL ALLOCATIONS OF ARTS, CULTURE AND COMMUNITY FESTIVALS (ACCF) FUNDING AWARDS, PURSUANT TO COUNCIL POLICY 100-23, TO NONPROFIT ORGANIZATIONS WITH EXISTING CONTRACTS WITH THE CITY OF SAN DIEGO'S COMMISSION FOR ARTS AND CULTURE.

WHERBAS, the San Diego City Council (City Council) adopted Council Policy 100-23, titled "City Council Funding of Arts, Culture and Community Festivals with Discretionary Transient Occupancy Tax Allocations," on Aug. 13, 2012, by San Diego Resolution R-307625; and

WHEREAS, among other things, Council Policy 100-23 establishes uniform guidelines, conditions, and criteria governing the application for, and granting of, funds to nonprofit organizations for the purpose of supporting their ongoing operational expenses and their sponsorship of special events at the discretion of each Councilmember during the fiscal year; and

WHEREAS, funding for Arts, Culture and Community Festivals (ACCF) from each Councilmember's annual allocation of Transient Occupancy Tax (TOT) may be awarded to private nonprofit organizations that produce programs, projects, and events that provide access to excellence in culture and the arts for residents of, and visitors to, the City of San Diego (City), and enrich the lives of the people of San Diego and build healthy, vital neighborhoods; and

WHEREAS, Council Policy 100-23 requires each grant of ACCF funding to a private nonprofit organization be done by City Council resolution; and

WHEREAS, for Fiscal Year 2023, Council Districts 1, 2, 3, 4, 5, 6, 8, and 9 recommend awarding ACCF funds in an aggregate amount not to exceed \$236,300 to nonprofit organizations that have existing contracts with the City (Attachment 1); and

WHEREAS, the existing contracts between the nonprofit organizations and the City are administered by the City's Commission for Arts and Culture for Organizational Support Program (OSP) funding and Creative Communities San Diego (CCSD) funding; and

WHEREAS, rather than executing new contracts for each nonprofit organization, the City's Commission for Arts and Culture may amend the existing OSP and CCSD contracts to include the recommended ACCF grant awards to each nonprofit as identified in Attachment 1; and

WHEREAS, it is the determination of the City Council that the use of ACCF funds by each nonprofit organization fits within the parameters of Council Policy 100-23 but for events or programs that have already occurred and goods, supplies, or materials that have already been purchased; and

WHEREAS, the Office of the City Attorney has drafted this resolution based on the information provided by City staff, including information provided by affected third parties and verified by City staff, with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. The Fiscal Year 2023 allocations of ACCF funding awards identified in Attachment 1, pursuant to Council Policy 100-23, to nonprofit organizations with existing contracts for OSP and CCSD awards with the City's Commission for Arts and Culture are approved.

The Adams Avenue Business Association's mission is to increase commercial activity within the Adams Ave commercial corridor. The 40th annual Adams Avenue Street Fair (AASF) is the AABA's major promotion and fundraising activity scheduled for September 24th & 25th, 2022. The '20 and '21 editions were cancelled due to the pandemic. AASF is held in the community of Normal Heights within the Adams Avenue Business District and staged on 7 blocks of Adams Ave & inside Adams Park. It is San Diego's largest free music event with 65 performances on 6 outdoor stages: San Diego's largest showcase of local musical talent employing approx. 300 local musicians. The event also includes 275 vendor booths; many of whom are artists and crafters exhibiting their creations. Besides music and shopping, the event features 4 beer gardens, craft beer taste, festival foods and giant carnival rides set in Adams Park. AASF was first held in 1981 to celebrate the beginning of community revitalization efforts along Adams Avenue. The event has grown from a small neighborhood block party to a regionally significant event, becoming one of San Diego's largest free civic gatherings drawing 100,000 attendees over the weekend. Although AASF draws a countywide audience and attracts out-of-town visitors, the majority of its attendees are drawn from San Diego's diverse Mid City community, providing the areas low- mod residents a unique opportunity to hear a wide variety of genres & quality performing artists. Attendees also gather at the event to eat, drink, socialize, shop, people watch and celebrate. The AASF also serves as an economic development activity for 450 small business operators and their employees participating in the event and generates \$2.6 Million in direct spending. AASF requires 950 individuals to set-up and operate the event, not including business storefronts located in the footprint, 65 community members receive stipends working the event managing vendor areas, stages, beer gardens, information booths & parking, 875

professionals work the event including vendors, musicians, PD, stage & sound techs, security, maintenance, etc.
