

RESOLUTION NUMBER R- 314553DATE OF FINAL PASSAGE DEC 21 2022

A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO DECLARING THE CITY OF SAN DIEGO TO BE
A SAFE CITY FOR TRANSGENDER, NON-BINARY, AND
GENDER DIVERSE YOUTH.

WHEREAS, the City of San Diego (City) believes that every resident deserves to be treated with dignity and respect; and

WHEREAS, the City is committed to equal justice for all, including children and youth; and

WHEREAS, all children and youth should be able to attend school and live in a safe and inclusive environment free from prejudice and discrimination; and

WHEREAS, the lack of awareness, understanding, and resistance to the issues facing LGBTQIA+ children and youth has contributed to a higher rate of isolation, depression, and suicidal ideations or attempts; and

WHEREAS, LGBTQIA+ youth who do not feel affirmed in their identity are more likely to attempt suicide and self-harm than those who do feel affirmed; and

WHEREAS, the rates of depression, anxiety, isolation, and suicidal ideation are significantly higher for transgender, non-binary, and gender diverse youth; and

WHEREAS, a majority of transgender, non-binary and gender diverse youth are rejected by families and become socially displaced, disproportionately increasing the likelihood of these individuals being housing insecure and victims of human sex trafficking; and

WHEREAS, the City recognizes the importance of letting transgender, non-binary, and gender diverse youth know that they are seen and valued for who they are, protected from stigmatizing policies that jeopardize their health and well-being, and supported by a community that wants to see them thrive; and

WHEREAS, the Office of the City Attorney has drafted this resolution based on the information provided by City staff, with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the City of San Diego is hereby declared a safe city for transgender, non-binary, and gender diverse youth.

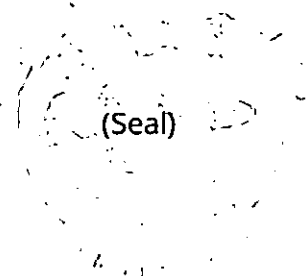
