A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO CONFIRMING APPOINTMENTS OF
COUNCILMEMBERS TO STANDING COMMITTEES FOR
CALENDAR YEAR 2023.

WHEREAS, Rule 6.1 of the Rules of the Council, San Diego Municipal Code section 22.0101, provides for specific standing committees of the Council of the City of San Diego (Council); and

WHEREAS, Rule 6.2.1 provides that no later than the second Council meeting in January of each year, the Council President shall nominate the committee chair, vice chair, and committee members for each committee, subject to confirmation by a majority vote of the Council; and

WHEREAS, on December 6, 2022, Council adopted San Diego Ordinance O-2023-83 amending the Rules of Council to, among other things, add a new standing committee and require the Council President's nomination indicate the number of committee members assigned to each standing committee, except the Committee on Rules; and

WHEREAS, these amendments to the Rules of Council will become effective thirty days after final passage of Ordinance O-2023-83; and

WHEREAS, Council President Sean Elo-Rivera submitted nominations for the committee chairs, vice chairs, and committee members for the standing committees of the Council for calendar year 2023, and now seeks Council confirmation of the appointments; and

WHEREAS, Council desires to make the standing committee appointments based on the pending amendments to the Rules of Council and have the appointments become effective when the amendments become effective; and

WHEREAS, the additional appointments of Councilmembers to serve on the City's Audit Committee, which is governed by the San Diego Charter, and appointment of a Council President Pro Tem will be considered by the Council in separate actions and are not included in this resolution; and

WHEREAS, the Office of the City Attorney has drafted this resolution based on the information provided by City staff, with the understanding that this information is complete, true, and accurate; and

WHEREAS, under San Diego Charter section 280(a)(1), this resolution is not subject to veto by the Mayor because this matter is exclusively within the purview of the Council and not affecting the administrative service of the City under the control of the Mayor; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, the Council confirms the Economic Development and Intergovernmental Relations Committee shall have three committee members, and the Active Transportation and Infrastructure Committee, Budget and Government Efficiency Committee, Community and Neighborhood Services Committee, Environment Committee, Land Use and Housing Commission, and Public Safety Committee shall each have four committee members; and

BE IT FURTHER RESOLVED, that the Council confirms the following appointments of the committee chair, vice chair, and committee members for each standing committee pursuant to Municipal Code section 22.0101, to serve for a term of one year, and until a successor is duly appointed and confirmed:
