WHEREAS, it is now necessary for the Council to confirm the appointments of the two Councilmembers to the Audit Committee for calendar year 2023; and

WHEREAS, the Office of the City Attorney has drafted this resolution based on the information provided by City staff, with the understanding that this information is complete, true, and accurate; and

successor is duly appointed and confirmed, and shall serve as the chair of the Audit Committee.

BE IT FURTHER RESOLVED, that Councilmember Vivian Moreno is hereby appointed

to serve on the Audit Committee for calendar year 2023 and until a successor is duly appointed

and confirmed, and shall serve as vice chair of the Audit Committee.
