AN ORDINANCE OF THE COUNCIL OF THE CITY OF
SAN DIEGO AUTHORIZING THE FIRST AMENDMENT TO
THE CONTRACT RESULTING FROM ITB NO. 10058074-16-L
FOR DISPOSAL SITES FOR EXCAVATED MATERIAL IN
ANY COMBINATION BETWEEN THE CITY OF SAN DIEGO
AND VULCAN MATERIALS COMPANY AND RELATED
ACTIONS.

WHEREAS, the City of San Diego (City) Public Utilities, Transportation, and Storm
Water Departments excavate and dispose of approximately 45,000 tons of spoil that contains any
combination of wet soil, rock, dirt, adobe clay, wet adobe clay, concrete with rebar, asphalt, and
asphalt with petromat; and

WHEREAS, on June 18, 2015, the City issued an Invitation to Bid (ITB No. 10058074-
16-L) to procure a contractor for services to be provided to the City for the disposal of excavated
material in any combination, in accordance with the specifications of the ITB, and the City
determined that Vulcan Materials Company (Vulcan) had the expertise, experience, and
personnel necessary to provide the specified services, and the contract went into effect on
June 26, 2016, expiring on June 25, 2021 (Contract); and

WHEREAS, a new contract with Vulcan for the same services went into effect on
August 15, 2022 (ITB 10089840-22-L), but in between the effective dates of these two contracts,
services were rendered, and invoices were received by the City for this necessary service. The
First Amendment to the Contract allows for the retroactive approval to process these invoices;
and

WHEREAS, even after the Contract expired, the Parties continued to act as if the
Contract was in effect, and Vulcan continued to provide services to the City ensuring safe and
environmentally friendly handling and disposal; and

WHEREAS, this action is to request authorization to execute the First Amendment to the Contract to extend the Term of the Contract from June 25, 2021 to August 14, 2022 and to increase the contract not to exceed amount by \$1,157,000 from \$9,462,928 to \$10,619,928, in order to clarify the terms and conditions under which the services were provided during that time, and to allow the City to pay the invoices for the services provided during that period; and

WHEREAS, under Charter section 99, no contract, agreement or obligation extending for a period of more than five years may be authorized except by Ordinance approved by a two-thirds majority vote of the City Council; and

WHEREAS, the Office of the City Attorney has drafted this ordinance based on the information provided by City staff, with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Mayor, or designee, is authorized to execute the First Amendment to the five year Agreement with Vulcan Materials Company (ITB 10058074-16-L), for the disposal of excavated material to be retroactively effective from June 25, 2021 to August 14, 2022, for the additional amount of \$1,157,000, bringing the total not to exceed amount to \$10,619,928.

Section 2. That the Chief Financial Officer is authorized to expend an amount not to exceed \$1,157,000, in total, as retroactive payment for services provided from June 25, 2021 through August 14, 2022, estimated to be funded as follows: \$400,000 from Fund 700011, Water Utility Operating, \$375,000 from Fund 700000, Muni Sewer Revenue, \$20,000 from Fund 100000, General Fund Stormwater, and \$362,000 from Fund 100000, General Fund Transportation, for the purpose of funding the services agreement with Vulcan Materials Company.

Section 3. That a full reading of this ordinance is dispensed with prior to passage, a written copy having been made available to the Council and the public prior to the day of its passage.

Section 4. That this ordinance shall take effect and be in force on the thirtieth day from and after its final passage.
