AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING A FIRST AMENDMENT TO THE AGREEMENT FOR LEGAL SERVICES WITH WOOD SMITH HENNING & BERMAN LLP IN THE FORMER NAVAL TRAINING CENTER BOAT CHANNEL MATTER, EXTENDING THE TERM OF THE AGREEMENT AND AUTHORIZING ADDITIONAL FUNDING FOR SUCH AMENDMENT.

WHEREAS, on April 24, 2018, pursuant to San Diego Resolution R-311707 (Apr. 25, 2018), the San Diego City Council (City Council) authorized the retention of Wood Smith Henning & Berman LLP (Law Firm) as outside counsel in connection with the former Naval Training Center (NTC) Boat Channel matter; and

WHEREAS, on June 27, 2018, pursuant to this City Council authorization, the City of San Diego and Law Firm executed an Agreement for Legal Services in an amount not to exceed \$250,000 (Agreement); and

WHEREAS, the Law Firm will soon exceed the maximum not to exceed amount set forth in the Agreement; and

WHEREAS, on March 27, 2023, the Department of the Navy filed a lawsuit against the City in this matter in federal court under the Comprehensive Environmental Response, Compensation, and Liability Act (CERCLA), which is a complex and specialized area of law; and

WHEREAS, due to the legal complexity and magnitude of this matter, the Law Firm's expertise in CERCLA, and the Law Firm's knowledge of the facts and issues in this case, the City continues to require the Law Firm's legal services; and

WHEREAS, the City wishes to retain the Law Firm for an additional five years; and

WHEREAS, an increase of \$200,000 to the Agreement, which would raise the total not to exceed amount to \$450,000, is necessary to avoid a disruption in the Law Firm's services and to allow the Law Firm to continue its representation of the City; and

WHEREAS, once approved and executed, the First Amendment shall be effective retroactively to June 27, 2023; and

WHEREAS, under San Diego Charter section 99, no contract, agreement, or obligation extending for a period of more than five years may be authorized except by Ordinance approved by a two-thirds majority vote of the City Council; and

WHEREAS, the Office of the City Attorney has drafted this ordinance based on the information provided by City staff, including information provided by affected third parties and verified by City staff, with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the First Amendment to the Agreement for Legal Services is approved and the Mayor or his designee is authorized to execute the First Amendment for and on behalf of the City with Wood Smith Henning & Berman LLP for an additional \$200,000, for a total Agreement amount not to exceed \$450,000, and to extend the Agreement for an additional five years, under the terms and conditions set forth in the First Amendment to the Agreement.

Section 2. That the Chief Financial Officer is authorized to expend an additional \$200,000, for a total amount not to exceed \$450,000 from General Fund 100000, Storm Water Department operating budget, for the purpose of executing the First Amendment to the Agreement with Law Firm, contingent upon the adoption of the Annual Appropriations Ordinance for the applicable Fiscal Year and the Chief Financial Officer first furnishing one or

more certificates certifying that funds necessary for the expenditure are, or will be, on deposit with the City Treasurer.

Section 3. That a full reading of this Ordinance is dispensed with prior to passage, a written copy having been made available to the Council and the public prior to the day of its passage.

Section 4. That this Ordinance shall take effect and be in force on the thirtieth day from and after its final passage.
