AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE OBLIGATIONS OF CONSTRUCTION CONTRACT K-18-1739-DBB-3 WITH NEWEST CONSTRUCTION COMPANY, INC. TO EXTEND BEYOND FIVE YEARS UNTIL JUNE 8, 2025, TO COMPLETE CONSTRUCTION OF CIP A-BJ.00001, WATER PUMP STATION RESTORATION (B-11072, SOLEDAD PUMP STATION UPGRADES).

WHEREAS, in 2018, Construction Contract K-18-1739-DBB-3 was advertised and awarded to NEWest Construction Company, Inc. with the lowest responsible and responsive bid price of \$6,889,760 (Agreement); and

WHEREAS, the Agreement has an effective date of May 30, 2018; and

WHEREAS, approximately 70% of the work has been completed including construction of the new pump station building, installation of two 75 Horsepower (HP) vertical turbine and constant speed pumps, two 50 HP vertical turbine and variable frequency drive pumps, and approximately 70% of the security fencing; and

WHEREAS, the remaining work left to be completed includes demolition of the exiting pump station, installation of the remaining security fencing, inlet/outlet piping, the installation of the reservoir water mixing system, landscaping, paving, and associated control system start up, testing and commissioning of the new pump station; and

WHEREAS, the obligations of the Agreement need to be extended beyond five years until June 8, 2025, to allow NEWest Construction Company Inc. to complete the remaining scope of work; and

WHEREAS, all other terms and conditions of the Agreement are to remain the same; and

WHEREAS, under San Diego Charter section 99, no contract, agreement, or obligation extending for a period of more than five years may be authorized except by Ordinance approved by a two-thirds majority vote of the City Council; and

WHEREAS, the Office of the City Attorney has drafted this Ordinance based on the information provided by City staff with the understanding that this information is complete, true, and accurate: NOW, THEREFORE.

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the City Council hereby authorizes the obligations of the Agreement (K-18-1739-DBB-3) to extend beyond five years until June 8, 2025.

Section 2. That a full reading of this ordinance is dispensed with prior to passage, a written copy having been made available to the Council and the public prior to the day of its passage.

Section 3. That this ordinance shall take effect and be in force on the thirtieth day from and after its final passage.
