AN ORDINANCE AMENDING CHAPTER 2, ARTICLE 6, DIVISION 16 OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTIONS 26.1602 AND 26.1604 RELATING TO THE CITY OF SAN DIEGO YOUTH COMMISSION.

WHEREAS, the City of San Diego Youth Commission (Commission) is established in San Diego Municipal Code (Municipal Code) section 26.1601 to "serve as an advisory body to the Mayor, City Council, and City Manager on issues of interest to youth and pertaining to youth in the City of San Diego"; and

WHEREAS, the Commission consists of 20 members, who shall be residents of the City of San Diego (City) and between the ages of 14 and 22; and

WHEREAS, the City wishes to raise the maximum age limit for members of the Commission to 25 years of age; and

WHEREAS, on June 7, 2023, the Council of the City of San Diego's (Council) Land Use and Housing Committee recommended Council approve the proposed amendments with a request to further amend the Municipal Code to change who shall serve as liaison to the Commission from a member of the Council, or designee, to the Mayor, or designee; and

WHEREAS, the Office of the City Attorney has drafted this Ordinance based on the information provided by City staff, with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That Chapter 2, Article 6, Division 16 of the San Diego Municipal Code is amended by amending sections 26.1602 and 26.1604, to read as follows:

### § 26.1602 Youth Commission Established

There is hereby created a City of San Diego Youth Commission (Commission), consisting of twenty members who shall serve without compensation. The members shall be appointed by the Mayor and confirmed by the City Council. The Mayor shall appoint two members from the nominees provided by each member of the City Council, and two additional members chosen by the Mayor. Vacancies shall be filled in the same manner. Members shall serve two-year terms, and each member shall serve until a successor is duly appointed and confirmed. No member shall serve more than two consecutive terms. The expiration date of all terms shall be July 1. Members of the Commission shall be residents of the City of San Diego between the ages of 14 and 25. If any member of the Commission reaches the age of 26 while serving on the Commission, the appointment of that member shall expire the following July 1. The Mayor shall designate a Chair and a Vice Chair from among the members of the Commission.

### § 26.1604 Youth Commission Liaison

The Mayor, or designee, shall serve as the Youth Commission Liaison. The Youth Commission Liaison shall attend the meetings of the Youth Commission, and shall facilitate the conduct of the Commission's meetings. The Youth Commission Liaison shall coordinate with staff to schedule the dates, times, and locations of each Youth Commission meeting.

Section 2. That a full reading of this Ordinance is dispensed with prior to passage, a written copy having been made available to the Council and the public prior to the day of its passage.

Section 3 That this Ordinance shall take effect and be in force on the thirtieth day from

## § 26.1602 Youth Commission Established

There is hereby created a City of San Diego Youth Commission (Commission), consisting of twenty members who shall serve without compensation. The members shall be appointed by the Mayor and confirmed by the City Council. The Mayor shall appoint two members from the nominees provided by each member of the City Council, and two additional members chosen by the Mayor. Vacancies shall be filled in the same manner. Members shall serve two-year terms, and each member shall serve until a successor is duly appointed and confirmed. No member shall serve more than two consecutive terms. The expiration date of all terms shall be July 1. Members of the Commission shall be residents of the City of San Diego between the ages of 14 and 22 25. If any member of the Commission reaches the age of 23 26 while serving on the Commission, the appointment of that member shall expire the following

July 1. The Mayor shall designate a Chair and a Vice Chair from among the members of the Commission.

# § 26.1604 City Council Youth Commission Liaison

The City Council Shall designate one of its members to Mayor, or designee, shall serve as the City Council Youth Commission Liaison to the Youth Commission.

The City Council Youth Commission Liaison, or a designee from his or her staff, shall attend the meetings of the Youth Commission, and shall facilitate the conduct of the Commission's meetings. The City Council Youth Commission Liaison shall coordinate with staff to schedule the dates, times, and locations of each Youth Commission meeting.
