## DATE OF FINAL PASSAGE SEP 18 2023

AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE MAYOR OR HIS DESIGNEE TO EXECUTE AMENDMENT NO. I TO CONTRACT H207152 WITH BLUE LAKE CIVIL FOR PROFESSIONAL ENGINEERING SERVICES FOR AC WATER AND SEWER GROUP JOB 1033 AND RELATED ACTIONS.

WHEREAS, in March 2020, the City prepared and advertised a Request for Proposal for selection of a consultant to provide professional engineering services for AC Water And Sewer Group Job 1033; and

WHEREAS, through the competitive selection process, Blue Lake Civil (Consultant) was identified as the most highly qualified consultant; and

WHEREAS, on August 3, 2021, the San Diego City Council (Council) passed Ordinance

No. O-21363 authorizing the Mayor, or his designee, to execute a consultant agreement with

Consultant to provide professional engineering services to prepare plans, specifications, and cost

estimates for completion of AC Water and Sewer Group Job 1033; and

WHEREAS, the City and Consultant entered into Contract H207152 to provide

professional engineering services for AC Water And Sewer Group Job 1033 (Agreement); and

WHEREAS, during the design phase of the Project, additional necessary design

requirements for AC Water And Sewer Group Job 1033 were identified; and

WHEREAS, an amendment to the Agreement is now necessary in order to cover the additional design requirements (Amendment No. 1); and

WHEREAS, under Charter section 99, no contract, agreement, or obligation extending for a period of more than five years may be authorized except by Ordinance approved by a twothirds majority vote of the City Council; and

WHEREAS, the Office of the City Attorney has drafted this ordinance based on the information provided by City staff with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Mayor, or his designee, is authorized to execute Amendment No. 1 to the Agreement in CIP A-KB.00003, Main Replacements (B-18021, AC Water and Sewer Group Job 1033 (W)); and in CIP A-JA.00001, Sewer Main Replacements (CIP B-18022, AC Water and Sewer Group Job 1033 (S)), extending the term of the Agreement through July 24, 2028, and in an amount not to exceed \$975,270, which Amendment No. 1 is included in the staff materials accompanying this ordinance, and that once signed, will be on file in the Office of the City Clerk as Document No. 00 - 21717.

Section 2. That the Chief Financial Officer is authorized to expend an amount not to exceed \$975,270; of which, \$594,914.70 is in CIP A-KB.00003, Main Replacements (B-18021, AC Water and Sewer Group Job 1033 (W)), Fund 700010, Water Utility CIP; and \$380,355.30 is in CIP A-JA.00001, Sewer Main Replacements (B-18022, AC Water and Sewer Group Job 1033 (S)), Fund 700008, Muni Sewer CIP, for the purpose of executing Amendment No. 1, contingent upon the Chief Financial Officer furnishing one or more certificates certifying that the funds necessary for expenditure under the established phase funded schedule are, or will be, on deposit with the City Treasurer.

Section 3. That a full reading of this Ordinance is dispensed with prior to passage, a

written copy having been made available to the Council and the public prior to the day of its passage.

Section 4. That this Ordinance shall take effect and be in force on the thirtieth day from and after its final passage.
