AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING EXECUTION OF THE FIRST AMENDMENT TO THE MASTER SERVICES AGREEMENT WITH ZENSAR TECHNOLOGIES, INC.

WHEREAS, the City of San Diego's (City) network is the core service used to deliver most of the technical services to staff and the public and network services are comprised of two primary components (with multiple subcomponents): data services and voice services; and

WHEREAS, the City and Zensar Technologies IM, Inc. entered into a Master Services Agreement for the provision of Network Services (Agreement), as authorized by Council Ordinance No. O-20907 and the Agreement was novated to Zensar Technologies, Inc. (Zensar) effective as of July 1, 2020, and

WHEREAS, Zensar, in its role as the City's network services provider, is primarily responsible for the provision, management, modernization, and continued support of these services on a 24 hour, 7 days per week basis; and

WHEREAS, due to additional costs necessary to modernize network systems, add additional cybersecurity defenses and to address needs that the pandemic created, the City seeks approval to execute the First Amendment to the Agreement to allow Zensar to continue to perform required run-the-business activities and desired modernization projects through the current and remaining Option Periods and conclusion of the Disentanglement Period; and

WHEREAS, under San Diego Charter section 99, no contract, agreement, or obligation extending for a period of more than five years may be authorized except by Ordinance approved by two-thirds majority vote of the City Council; and

WHEREAS, the Office of the City Attorney has drafted this ordinance based on the information provided by City staff, with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Mayor or his designee is authorized to execute, for and on behalf of the City, the First Amendment to the Agreement between the City of San Diego and Zensar Technologies, Inc. for Network Services to increase the not to exceed amount to \$159,206,654 over the full term of the Agreement and otherwise modifying the Agreement pursuant to the terms and conditions contained in the First Amendment to the Agreement on file with the Office of the City Clerk as Document No. OO-

Section 2: That the Chief Financial Officer is authorized to expend a total amount not to exceed \$159,206,654 over the full term of the Agreement, contingent upon adoption of the annual Appropriation Ordinance for the applicable fiscal year and upon the Chief Financial Officer furnishing one or more certificates certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

Section 3. That a full reading of this ordinance is dispensed with prior to passage, a written copy having been made available to the Council and the public prior to the day of its passage.

Section 4. That this ordinance shall take effect and be in force on the thirtieth day from and after its final passage.
