A RESOLUTION OF THE COUNCIL OF THE CITY OF  
SAN DIEGO TO ACCEPT, APPROPRIATE, AND EXPEND  
TWO GRANT AWARDS FROM THE CALIFORNIA  
GOVERNOR'S OFFICE OF EMERGENCY SERVICES AND TO  
AUTHORIZE THE SAN DIEGO CITY ATTORNEY TO  
EXECUTE THE GRANT AGREEMENT AND RELATED  
DOCUMENTS.

WHEREAS, Your Safe Place – A Family Justice Center (YSP), within the Office of the  
San Diego City Attorney, collaborates with community partners to provide safety planning and  
supportive services to individuals experiencing domestic violence, sexual assault, sex trafficking,  
elder abuse, and family violence; and

WHEREAS, on August 9, 2022, the California Governor's Office of Emergency Services  
(Cal OES) awarded grant funds in the amount of \$65,000 through the Sexual Assault American  
Rescue Plan (AR) Program, Grant Subaward No. AR22 01 7979 (AR Program Grant Award), to  
the City of San Diego (City) on behalf of YSP; and

WHEREAS, the AR Program Grant Award will enhance YSP's ability to meet the  
emergency needs of sexual assault survivors in response to the COVID-19 pandemic; and

WHEREAS, the AR Program Grant Award is available for expenditure from October 1,  
2022 through September 30, 2024 (AR Program Grant Performance Period); and

WHEREAS, on September 30, 2022, YSP applied for grant funds through Cal OES's  
Unserved/Underserved Victim Advocacy and Outreach (UV) Program; and

WHEREAS, YSP is waiting to be notified whether Cal OES will award the City  
\$196,906 in UV Program grant funds (UV Program Grant Award); and

WHEREAS, if awarded, the UV Program Grant Award will enable YSP to increase access to culturally appropriate victim services for unserved and underserved survivors of crime; and

WHEREAS, if awarded, the UV Program Grant Award is available for expenditure from January 1, 2023 through December 31, 2023 (UV Program Grant Performance Period); and

WHEREAS, Cal OES requires YSP certify by Council of the City of San Diego (City Council) Resolution that the City Attorney is authorized to execute specific grant award agreements and other related documents, including grant award amendments, extensions, or renewals that may become necessary; and

WHEREAS, Cal OES confirmed City Council may authorize the City Attorney to enter specific grant award agreements, and enter applicable grant award amendments, extensions, or renewals that may become necessary, that have been applied for but have not yet been granted; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. The Cal OES AR Program Grant Award is accepted in an amount not to exceed \$65,000 for the AR Program Grant Performance Period.
2. The City Attorney is authorized to execute the AR Program Grant Award Agreement retroactively, and execute any amendments, extensions, or renewals of the AR Program Grant Award Agreement that may become necessary for a period of up to five years from Fiscal Year 2022 through and including Fiscal Year 2027.
3. The Chief Financial Officer is authorized to accept, appropriate, and expend up to \$65,000 in AR Program Grant Award funds.

4. If awarded, the Cal OES UV Program Grant Award is accepted in an amount not to exceed \$196,906 for the UV Program Grant Performance Period.

5. If awarded, the City Attorney is authorized to execute the UV Program Grant Award Agreement, and execute any amendments, extensions, or renewals of the UV Program Grant Award Agreement that may become necessary for a period of up to five years from Fiscal Year 2022 through and including Fiscal Year 2027.

6. If awarded, the Chief Financial Officer is authorized to accept, appropriate, and expend up to \$196,906 in UV Program Grant Award funds.

7. That any expenditures to date consistent with the AR Program Grant Award are ratified.

8. That the Chief Financial Officer is authorized to establish a special interest-bearing account for the AR Program Grant Award and UV Program Grant Award, if required.


