A RESOLUTION OF THE COUNCIL OF THE CITY OF  
SAN DIEGO CONFIRMING THE APPOINTMENT TO THE  
SAN DIEGUITO RIVER VALLEY REGIONAL OPEN SPACE  
JOINT POWERS AUTHORITY BOARD FOR CALENDAR  
YEAR 2023.

WHEREAS, each year the City appoints elected officials to serve as representatives, alternates, and liaisons to various outside boards, commissions, committees, and governmental agencies; and

WHEREAS, on December 13, 2022, by memorandum, Mayor Todd Gloria and Council President Sean Elo-Rivera recommended appointments of elected officials to serve as the City's representatives, alternates, and liaisons to various boards, commissions, committees, and governmental agencies, subject to Council confirmation; and

WHEREAS, the Council of the City of San Diego confirmed the appointments on December 15, 2022, appointing Councilmembers Kent Lee and Marni von Wilpert to the San Dieguito River Valley Regional Open Space Park Joint Powers Authority Board for calendar year 2023; and

WHEREAS, the Mayor and Council President would like to appoint Councilmember Joe LaCava to the San Dieguito River Valley Regional Open Space Park Joint Powers Authority Board, replacing Councilmember Kent Lee as one of the City's designated representatives; and

WHEREAS, the Office of the City Attorney has drafted this resolution based on the information provided by City staff, with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, hereby confirms the appointment of Councilmember Joe LaCava to the San Dieguito River Valley Regional Open Space Park Joint Powers Authority Board to serve through December 2023, and until a successor is duly appointed and confirmed.




