A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO AMENDING THE 2023 LEGISLATIVE
CALENDAR, THE FISCAL YEAR 2024 BUDGET
DEVELOPMENT AND FISCAL YEAR 2023 BUDGET
MONITORING KEY DATES.

WHEREAS, each year, the Council of the City of San Diego (City Council) adopts a schedule of meetings for the calendar year for the City Council and its Standing Committees, commonly referred to as the legislative calendar; and

WHEREAS, under San Diego Charter section 280(a)(1), this resolution is not subject to veto by the Mayor because this matter is exclusively within the purview of the City Council and not affecting the administrative service of the City under the control of the Mayor; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the 2023 Legislative Calendar is hereby amended as reflected in the amended 2023 Legislative Calendar, a copy of which is on file in the Office of the City Clerk as Document No. RR- 314583-!

BE IT FURTHER RESOLVED, that the Fiscal Year 2024 Budget Development and Fiscal Year 2023 Budget Monitoring Key Dates are hereby amended as reflected in the amended Fiscal Year 2024 Budget Development and Fiscal Year 2023 Budget Monitoring Key Dates, a copy of which is on file in the Office of the City Clerk as Document No. RR- 314583 - 2
