A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO AUTHORIZING THE FIRST AMENDMENT TO
THE COOPERATIVE PROCUREMENT CONTRACT WITH
MALLORY SAFETY AND SUPPLY, LLC FOR THE
PURCHASE OF SAFETY EQUIPMENT, PERSONAL
PROTECTIVE EQUIPMENT, AND SAFETY SUPPLIES

WHEREAS, on February 28, 2022, the City of San Diego entered into a cooperative procurement contract with Mallory Safety and Supply, LLC (Contract) for the purchase of safety equipment, personal protective, equipment and safety supplies; and

WHEREAS, the current not-to-exceed amount of the Contract is \$3,000,000 which was intended for Fire-Rescue to purchase public safety and emergency preparedness equipment and related services over the term of the Contract; and

WHEREAS, shortly after the Contract was executed, Fire-Rescue unexpectedly received additional funds from the Federal Emergency Management Agency, Urban Area Security Initiative grant to purchase public safety and emergency preparedness equipment and related services totaling approximately \$2,650,000; and

WHEREAS, Fire-Rescue expanded the scope of available purchases and will be able to purchase more equipment under the Contract because of the additional grant funding; and

WHEREAS, as a result, Fire-Rescue will exceed the \$3,000,000 not-to-exceed amount of the Contract; and

WHEREAS, the City now seeks to amend the cooperative procurement Contract by increasing the funding in the amount of \$3,000,000. The additional \$3,000,000 in funding increases the Contract not-to-exceed amount to \$6,000,000 through the end of the Contract term; and


WHEREAS, the Office of the City Attorney has drafted this resolution based on the information provided by City staff, with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,

BE IT RESOLVED, that the Mayor, or his designee is authorized to execute a First Amendment to the Contract to increase the Contract amount by \$3,000,000 for a total not-to-exceed amount of \$6,000,000, pursuant to the terms and conditions set forth in the Contract, on file with the Office of the City Clerk as Document No. RR-314632

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an additional \$3,000,000 for a total not-to-exceed amount of \$6,000,000 over the full term of the Contract, from General Fund 100000, for the purpose of executing this First Amendment, contingent upon the adoption of the Annual Appropriations Ordinance for the applicable fiscal year and contingent upon the Chief Financial Officer furnishing a certificate certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.




