A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO DETERMINING THAT APPROVAL OF FEE CONSOLIDATION AND OTHER REVISIONS TO THE MIRAMAR LANDFILL AND GREENERY FEE SCHEDULE IS STATUTORILY EXEMPT FROM THE CALIFORNIA ENVIRONMENTAL QUALITY ACT (CEQA) PURSUANT TO CEQA GUIDELINES SECTION 15273.

WHEREAS, the Environmental Services Department is seeking to revise the Fee Schedule for the Miramar Landfill and Greenery, to consolidate various fees, including flat rate fees, special handling fees, and fees for fibrous greens, green material, source-separated food material, and clean wood, from 39 categories down to 20 categories (Project); and

WHEREAS, the California State Legislature, through the California Environmental Quality Act (CEQA), Public Resources Code sections 21000-21189.70.10, has determined that CEQA does not apply to various types of projects listed therein; and

WHEREAS, California Public Resources Code Section 21084 states that CEQA Guidelines (Cal. Code Regs., title 14, sections 5000 to 15387 (CEQA Guidelines) shall list those classes of projects which have been determined not to have a significant effect on the environment and which shall be exempt from CEQA; and

WHEREAS, pursuant to that authority, CEQA Guidelines sections 15260-15285 list the statutory exemptions promulgated by the California State Legislature; and

WHEREAS, the Planning Department has determined that the Project is statutorily exempt from CEQA pursuant to CEQA Guidelines sections 15273; and

WHEREAS, the Council of the City of San Diego (Council) has considered the potential environmental effects of the Project; and

WHEREAS, the Council held a duly noticed public meeting and considered the written

record for the Project as well as public comment; and

WHEREAS, the Council, using its independent judgment, has determined that the Project

is statutorily exempt from CEQA, pursuant to CEQA Guidelines section 15273 (Rates, Tolls,

Fares, and Charges) because it involves the establishment, modification, structuring,

restructuring, or approval of rates, tolls, fares, or other charges by the City which are for the

purpose of: (1) Meeting operating expenses, including employee wage rates and fringe benefits;

(2) Purchasing or leasing supplies, equipment, or materials; (3) Meeting financial reserve needs

and requirements; (4) Obtaining funds for capital projects, necessary to maintain service within

existing service areas; or (5) Obtaining funds necessary to maintain such intra-city transfers as

are authorized by City charter; and

WHEREAS, the Office of the City Attorney has drafted this resolution based on the

information provided by City staff, with the understanding that this information is complete, true,

and accurate; NOW THEREFORE,

BE IT RESOLVED, that the Council of the City of San Diego determines that the Project

is statutorily exempt from the California Environmental Quality Act (CEQA) pursuant to CEQA

Guidelines section 15273.
