

RESOLUTION NUMBER R- 314651DATE OF FINAL PASSAGE MAR 17 2023A RESOLUTION OF THE COUNCIL OF THE CITY OF  
SAN DIEGO APPROVING FEE INCREASES FOR THE  
MIRAMAR LANDFILL AND GREENERY.

WHEREAS, pursuant to San Diego Municipal Code section 66.0129, the Mayor is authorized to periodically establish and revise fees for the Miramar Landfill and Greenery (Landfill), subject to City Council approval by resolution; and

WHEREAS, the City Council last approved an increase to Landfill fees in 2012; and

WHEREAS, an increase to Landfill fees is currently necessary to offset increases in operating costs and identified funding needs in the Refuse Disposal Enterprise; and

WHEREAS, on February 9, 2023, this item was heard at the Environment Committee, which recommended approval of this item; and

WHEREAS, in accordance with Administrative Regulation 95.25 section 5.1(d)(1), ten days' notice to the public of the City's intention to modify these fees was given by publication in the *San Diego Daily Transcript*; and

WHEREAS, the Office of the City Attorney has drafted this Resolution based on the information provided by City staff, with the understanding that this information is complete, true, and accurate; NOW THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that a fee increase of \$16.00 per ton is approved for all loads delivered to the Miramar Landfill and Greenery (Landfill) for disposal or processing, effective July 1, 2023; and

BE IT FURTHER RESOLVED, that an additional fee increase of \$14.00 per ton is approved for all loads delivered to the Landfill for disposal or processing, effective July 1, 2024.
